# 公司簡介 Corporate Profile

### 華潤集團於中國的城市燃氣分銷旗艦

華潤燃氣控股有限公司(「華潤燃氣」)主要由中國最大 的國有企業集團之一的華潤(集團)有限公司擁有。作為 中國領先的燃氣公用事業集團,華潤燃氣主要經營業務 包括天然氣購買及銷售、管道設施建設及運營、綜合服 務、冷熱電綜合能源、車船用氣等。華潤燃氣的業務策 略性地分佈於全國各地,主要位於經濟較發達和人口密 集的地區以及天然氣儲量豐富的地區。

憑藉良好的行業基礎及本集團的執行能力,華潤燃氣於 二零二三年繼續通過內涵式增長及收購實現快速擴張。 於二零二三年末,華潤燃氣的城市燃氣項目總共達276 個,分佈於中國25個省份,其中包括15個省會城市及 76個地級市,年燃氣總銷量達約388億立方米及客戶數 達5,778萬戶。

能源結構優化和環境污染治理將推動中國天然氣消費持 續增長。中國政府近年來採取多項措施提倡對污染較少 的能源資源的發展及使用。同傳統能源資源相比,天然 氣產業符合國家創新、協調、綠色、開放、共享的核心 發展理念,國家在「十四·五」規劃和2035年遠景目標綱 要草案中再次強調推動綠色低碳發展,加強生態文明建 設,天然氣的推廣及應用對保護生態環境、促進綠色轉 型具有重要作用。

中國仍是全球天然氣發展最重要區域,中國天然氣市場 仍處於重要發展期,華潤燃氣將會充分利用有利經營環 境,透過內涵及外延式增長持續擴張、在追求卓越表現 的同時努力提升其經營效率、提供安全可靠的清潔能源 供應並向客戶提供體貼、周到及高效的服務,向股東提 供不斷增長且可持續的業績表現,為僱員創造廣泛且專 業的個人發展機會,為中國及世界的環境保護及改善做 出貢獻,成為中國燃氣行業最受尊敬的領導者。



### THE PRC CITY GAS DISTRIBUTION FLAGSHIP OF CHINA RESOURCES GROUP

China Resources Gas Group Limited ("CR Gas"), substantially owned by China Resources (Holdings) Company Limited, one of the largest state-owned conglomerates in China, is a leading gas utilities group in China, the principal businesses of which include the purchases and sales of natural gas, the construction and operation of pipeline facilities, comprehensive service, combined cooling, heating and power, and gas for vehicles and vessels, etc. Its operations are strategically located in areas of China, which are economically more developed and densely populated and areas with rich reserves of natural gas.

Leveraging on the excellent industry fundamentals and the Group's execution competency, CR Gas continues to expand rapidly in 2023 via organic and acquisition growths. At the end of 2023, CR Gas's portfolio consisted of 276 city gas projects in 25 provinces of China including 15 provincial capitals and 76 prefecture level cities with an annual gross gas sales volume of some 38.8 billion cubic meters and 57.78 million customers.

The optimization of energy structure and environmental pollution control will promote the sustainable growth of natural gas consumption in China. The PRC government has, in recent years, taken various measures to promote the development and utilization of less polluting energy sources. The natural gas industry is in sync with the core development idea of innovation, harmony, green, open and sharing as compared with conventional energy resources. In "The 14th Five-Year Plan" and the draft of "Long-Range Objectives through the Year 2035", the state once again emphasized that the promotion of green and low-carbon development, the enhancement of the construction of ecological civilization and the promotion and application of natural gas played an important role in protecting the ecological environment and promoting the transition to green development.

The natural gas market in China is still in the important development period, as China remains the most important region in the global rise of natural gas development. CR Gas is well placed to take advantage of such a favorable operating environment and to become the most respectable leader in the PRC's gas industry by continuously expanding through organic and external growths; diligently enhancing its operational efficiency in pursue of excellence; delivering a safe and reliable supply of clean energy as well as the caring, competent and efficient service to our customers; offering growing and sustainable performance to shareholders; creating extensive professional and personal development opportunities to employees; and contributing to the protection and improvement of the Chinese and global environment.

### 全年業績

二零二三年,在地緣政治衝突加劇、國際 局勢複雜變化、多國面臨高通脹等大環境 下,世界經濟整體呈現弱復甦態勢。國際 貨幣基金組織估計,二零二三年全球經濟 全年增速為3.1%。年內,我國經濟恢復速 度在全球主要經濟體中處於領先地位,國 內生產總值(GDP)同比增長5.2%,經濟回 升向好。國家能源局在《中國天然氣發展報 告》中指出,天然氣作為最清潔低碳的化石 能源,是中國新型能源體系建設中不可或 缺的重要組成部分,當前及未來較長時間 內仍將保持穩步增長;天然氣靈活高效的 特性還可支撐與多種能源協同發展,在碳 達峰乃至碳中和階段持續發揮積極作用。

年內,本集團秉承追求卓越的進取精神, 制定「學標桿 再出發 創一流」的年度管 理主題,積極對標行業一流企業,高效推 動業務創新,持續提升運營效率,不斷鞏 固本集團在發達經濟區域城市燃氣市場的 核心優勢,憑藉良好的運營能力,本集團 之總天然氣銷量較去年同期增長8.1%至 387.8億立方米,營業額較去年同期增長 7.3%至1.012.7億港元,本公司擁有人應

### **ANNUAL RESULTS**

In 2023, in the context of intensified geopolitical conflicts, complex changes in the international situation, and high inflation in many countries, the overall world economy has shown a weak recovery trend. The International Monetary Fund forecasts that global economic growth by 3.1% in 2023. During the year, China's economic recovery took the lead among major economies in the world and experienced an economic upturn, with the gross domestic product (GDP) growing by 5.2% year-on-year. The China Natural Gas Development Report published by the National Energy Administration points out that natural gas, as the cleanest and lowest-carbon fossil energy, is an indispensable and important component in the construction of China's new energy system and its usage will continue to grow steadily for a long time. Natural gas's flexible and efficient characteristics can also support synergistic development of various energies and continue to play a positive role in the carbon peak and carbon neutrality.

During the year, the Group has adhered to the spirit of pursuing excellence by formulating the annual management theme of "benchmarking, rebeginning and creating first-class". Benchmarked against the leading companies in the industry, the Group efficiently promotes business innovation and continuously improves the operating efficiency in order to constantly consolidate the core advantages of the Group in the city gas market of sophisticated regions and cities. By leveraging on excellent operating capabilities, the Group's total natural gas sales volume increased by 8.1% from

### 天然氣銷售

二零二三年,全國天然氣表觀消費量 3,945.3億立方米,同比增長7.6%,國內天 然氣採購成本仍保持高位運行。年內,本 集團採取多項舉措保障天然氣供應能力, 並改善天然氣採購成本,共統籌氣量約 30.0億立方米,同比增長68.0%;共簽約煤 制氣、頁岩氣等非常規天然氣資源4.0億立 方米,預計節約天然氣採購成本約0.01元 人民幣/立方米;租賃地下儲氣庫超1.6億 立方米,通過天然氣代採代儲模式實現「夏 氣冬用」,預計將節約採暖季天然氣採購成 本約1,650萬元人民幣。 the same period last year to 38.78 billion cubic meters, the revenue increased by 7.3% from the same period last year to HK\$101.27 billion and the profit attributable to owners of the Company increased by 10.4% from the same period last year to HK\$5.22 billion. It is proposed to distribute a final dividend of 100.69 HK cents, resulting in a total dividend of 115.69 HK cents for the year, representing a dividend payout ratio of 50.3%.

### SALE OF NATURAL GAS

In 2023, the national apparent consumption of natural gas reached 394.53 billion cubic meters, representing an increase of 7.6% as compared with the corresponding period of last year. The domestic natural gas procurement costs still remained high. During the year, the Group took a number of measures to safeguard the supply capacity of natural gas and improve the cost of natural gas procurement, with a total gas volume of approximately 3.00 billion cubic meters and representing a year-on-year increase of 68.0%. A total of 400 million cubic meters of unconventional natural gas resources such as coalto-gas and shale gas were contracted, which is expected to save approximately RMB0.01/cubic meter of natural gas procurement cost. The leasing of 160 million cubic meters of underground gas storage to achieve "summer gas for winter use" (夏氣冬用) through the model of natural gas production and storage is expected to save approximately RMB16.50 million in the procurement cost of natural gas during the heating season.

年內,本集團共銷售387.8億立方米天然 氣,增長8.1%。其中工業銷氣量201.1億 立方米,增長7.2%,佔本集團銷氣量的 51.9%;商業銷氣量82.1億立方米,增長 9.0%,佔本集團銷氣量的21.2%;而居民 銷氣量則增長11.1%至94.4億立方米,佔 本集團銷氣量的24.3%。

### 新用戶開發

受益於本集團佔有較多的大型城市燃氣項 目,且多數項目分佈於京津冀區域、長三 角區域、成渝雙城經濟區、粵港澳大灣區 等國家重大戰略區域,本集團將持續擁有 穩定的用戶市場開發空間。本集團持續聚 焦城鎮燃氣用戶開發,緊抓「超大特大城市 推進城中村改造」的政策契機,加快居民 用戶開發,推進工業用戶節能技術改造, 結合國家安全整治契機,政企聯動推動商 業「瓶改管」。審慎開發周邊農村煤改氣用 戶,通過散煤替代實現能源結構優化。

年內,本集團新開發工商業用戶41,310 戶,新開發居民用戶331.3萬戶,其中:新 房接駁用戶283.3萬戶,舊房接駁用戶38.4 萬戶,煤改氣用戶4.6萬戶。本集團在中國 運營的城市燃氣專案平均氣化率由二零二 二年同期的58.2%上升至59.3%。 During the year, the Group sold 38.78 billion cubic meters of natural gas, an increase of 8.1%, of which industrial gas sales was 20.11 billion cubic meters, an increase of 7.2%, accounting for 51.9% of the Group's gas sales; commercial gas sales was 8.21 billion cubic meters, an increase of 9.0%, accounting for 21.2% of the Group's gas sales; and residential gas sales increased by 11.1% to 9.44 billion cubic meters, accounting for 24.3% of the Group's gas sales.

### **DEVELOPMENT OF NEW USERS**

Benefiting from the Group's relatively large-scale city gas projects, most of which are located in major national strategic regions such as the Beijing-Tianjin-Hebei Region, the Yangtze River Delta Region, the Chengdu-Chongqing Shuangcheng Economic Zone and the Guangdong-Hong Kong-Macau Greater Bay Area, the Group will continue to have a stable user market development space. The Group continued to focus on the development of urban gas users, seized the policy opportunity of promoting urban village transformation in megacities to accelerate the development of residential users, promote the transformation of energy-saving technology for industrial users, and took the opportunity of national security rectification to promote commercial "bottled-to-piped-gas conversion" through the linkage of government and enterprises. The Group prudently developed rural "coal-to-gas conversion" users around its projects, and optimised the energy structure by replacing bulk coal.

During the year, the Group had 41,310 new industrial and commercial users; 3,313,000 residential users were newly developed, including the connection to 2,833,000 new houses users, 384,000 old houses users, and 46,000 rural "coal-to-gas conversion" users. The average gas penetration rate of city gas projects operated by the Group in China increased from 58.2% for the same period of 2022 to 59.3%.

# 新項目拓展

本集團持續專注城市燃氣核心業務發展, 憑藉良好的企業品牌形象,二零二三年, 集團和成員公司層面新增簽約項目3個,註 冊項目8個,新增項目拓展經營區域4,057 平方公里,城市燃氣主業規模進一步擴 大。年內實現重慶燃氣集團股份有限公司 併表,獲取昆明煤氣(集團)控股有限公司 51%股權,完成廈門華潤燃氣有限公司2% 股權增持並實現併表,進一步夯實了公司 在核心城市燃氣主業的主導地位。

截至二零二三年十二月三十一日,集團層 面註冊城市燃氣項目數已經達到276個,遍 佈全國25個省份,其中包括:15個省會城 市,76個地級市。不斷擴大的經營區域及 項目優越的地理位置,為本集團核心業務 的持續快速增長奠定了堅實基礎。

### **EXPANSION OF NEW PROJECTS**

The Group continues to focus on the core business development of city gas by leveraging on its reputable corporate brand image. In 2023, 3 new projects were signed and 8 projects were registered at the Group and subsidiary level. The new projects expanded the operational region by 4,057 square kilometers, and the scale of the city gas business was further expanded. During the year, 重慶燃氣集 團股份有限公司 was consolidated into the financial statements of the Group, and it acquired 51% equity interest in 昆明煤氣 (集團) 控股有限公司, and the increase of 2% shareholding in 廈門華潤燃氣有限公司 was completed and consolidated, thus further consolidating the Company's leading position in the city gas core business.

As of 31st December, 2023, the number of registered city gas projects at the Group level reached 276, spanning across 25 provinces, including 15 provincial capital cities, and 76 prefecture-level cities. The ever-expanding operational regions and prime geographic locations of the projects have laid a solid foundation for the sustained and rapid growth of the Group's core business.

### 綜合服務業務

- 零 - = 年,本集團全面推廣維修、安 檢、抄表、綜合服務一體化網格服務模 式,覆蓋使用者超3000萬;著力打造「燃 氣管家|,使客戶從營業廳辦理業務變革為 燃氣管家提供線上服務; 萬餘名燃氣管家 成為經營綜合服務的「流動商店」,打造華 潤燃氣綜合服務特色的「百城萬店」 模式。 本集團旨在全方位提升客戶服務體驗,通 過企業微信等管理工具、95777全國統一服 務熱線及公眾號內容管理平臺等核心智慧 化載體,賦能燃氣管家更好服務使用者, 和安全服務為核心的智慧廚居一站式裝配 方案,客戶體驗全程無憂。年內,本集團 舉辦第四屆「美好生活節」線上營銷,成交 額達9.361萬元人民幣,創歷史新高;搭建 「潤燃臻選」網上商城,為客戶提供更加優 質的綜合服務產品和服務。

年內,綜合服務營業額由31.9億港元增長 27.0%至40.4億港元,分部溢利由11.5億 港元增長19.0%至13.7億港元,剔除匯率 波動影響,綜合服務營業額和分部溢利分 別增長33.3%和24.9%。本集團綜合服務業 務滲透率仍處於低位,相信通過持續深入 推廣,未來綜合服務業務將進入快速發展 階段,成為本集團重要業務組成部份。

### **COMPREHENSIVE SERVICE BUSINESS**

In 2023, the Group comprehensively promoted the integrated network service model of maintenance, safety inspection, meter reading and comprehensive services, covering more than 30 million users. The Group has endeavoured to develop "Gas Butler (燃氣管家)". which enables customers to change from doing business in a sales office to having a Gas Butler providing online service; Over 10,000 Gas Butlers has become a "mobile shop (流動商店)" operating comprehensive services, creating the "one million shops in one hundred cities (百 城萬店)" model characterised by the comprehensive services of CR Gas. The Group aims to improve customer service experience in all aspects, empowering Gas Butler to better serve its users and to realise that customers' needs can be met with our network through the management tools such as Enterprise WeChat and the core intelligent carriers such as the 95777 national unified service hotline and the public account content management platform. We provided one-stop intelligent kitchen and residence assembly solutions with the use of quality products and services as the core, providing customers with a hassle-free experience throughout the process. During the year, the Group held the fourth online marketing campaign of the "Good Life Festival (美好生活節)", with a turnover of RMB93.61 million, hitting a record high. The Group has built the online store of "Runran Selection (潤燃臻選)" to provide customers with better comprehensive products and services.

During the year, the comprehensive service turnover increased by 27.0% from HK\$3.19 billion to HK \$4.04 billion, and the segment profit increased by 19.0% from HK\$1.15 billion to HK\$1.37 billion. Excluding the effect of exchange rate fluctuations, the comprehensive service turnover and segment profit increased by 33.3% and 24.9%, respectively. The penetration rate of the Group's comprehensive service business is still at a low level. The Group believes that through continuously vigorous promotion, the comprehensive service business will step into a stage of rapid development in the future and become an important part of the Group's business.





# 綜合能源業務發展

二零二三年,本集團充分挖掘經營區域內 規模龐大的工商業使用者用能需求,利用 城市燃氣主業的管道優勢和土地資源優 勢,擇優選取分布式光伏、分布式能源和 交通充能的發展賽道,在燃氣供應基礎 上,創造綠電、冷熱、光儲充、能碳管理 等業務與主業融合發展的機會,不斷提升 綜合能源方案解決能力,打造具有華潤燃 氣特色的綜合能源業務。

年內,分布式能源業務新簽約30個項 目,累計項目數量達到173個,裝機規模 1.2GW:新簽約分布式光伏項目98個, 累計項目數量達到168個,裝機規模達 213.7MW。年內,本集團利用城市燃氣主 業優勢,共用資源和管道,在江蘇省南京 市江寧區合作開發整域分布式光伏項目, 裝機規模100MW,發電量1億度/年;在 雲南省昆明宜良工業園開發分布式集中供 熱項目,項目投資4,896萬元人民幣,蒸汽 銷量38萬噸/年;本集團亦積極拓展交通 充電業務,在浙江省台州市等地成立專業 化汽車充電公司,不斷拓展綁定公交用戶

### **COMPREHENSIVE ENERGY BUSINESS DEVELOPMENT**

In 2023, the Group fully explored the energy demand of large-scale industrial and commercial users in the operational region, made use of the pipeline advantage and land resources advantage of the city gas business, selected the best distributed photovoltaic, distributed energy and transportation charging business. Based on the gas supply, we created opportunities for the integration of green power, cooling and heating, solar energy storage and charging, energy and carbon management and other businesses with the main business, continued to enhance its comprehensive energy solution capability and built a comprehensive energy business with the characteristics of CR Gas.

During the year, the distributed energy business contracted 30 new projects, and the cumulative number of projects reached 173, with an installed capacity of 1.2GW; 98 new distributed photovoltaic projects were signed, with the cumulative number of projects reaching 168, and the installed capacity reaching 213.7MW. During the year, the Group leveraged on the strengths of its city gas business and shared resources and pipelines to jointly develop an area-wide distributed photovoltaic project in Jiangning District, Nanjing City, Jiangsu Province, with an installed capacity of 100MW and electricity generation of 100 million kwh per annum. In Yiliang Industrial Park in Kunming City, Yunnan Province, the Group developed a distributed central heating project, with a project investment of RMB48.96 million and steam sales volume of 380,000 tons per annum. The Group has

### 可持續發展

在企業快速發展過程中,本集團積極推進 董事會公司管治的發展,不斷完善董事會 與管理層職能,權責分明、各司其職、有 效制衡、科學決策,形成有效運轉的法人 治理結構。本集團高度重視誠信合規經 營,遵守法律法規、國際慣例和商業道 德,堅持以公平誠信原則處理與員工、供 應商、客戶、相關政府部門、合作夥伴以 及競爭者等利益相關方的關係,以誠信贏 得市場、贏得尊重,以合規經營提升本公 司內在品質和價值。

本集團高度重視在環境、社會、管治(ESG) 方面的管理,成立董事會領導下、本集團 各個部室共同參與的ESG工作小組,推動 ESG可持續發展管理體系全面落實。本集 團亦繼續聘用了顧問公司為本集團的ESG 管理體制、政策、資料披露、表現及實踐 等各方面提供專業建議,致力將本集團的 ESG表現進一步提升。本集團相信這些舉 措將會促進本集團的可持續發展,並為構 建更美好的生態環境作出貢獻。 also actively expanded the transportation charging business by setting up specialised vehicle charging companies in Taizhou City, Zhejiang Province and other places, continued to expand its sites for bonding bus users and piloted social charging station business. During the period, 61 charging stations were newly put into operation, resulting in a total of 232 charging stations being put into operation; the sale of electricity increased by 14.7% to 310 million kwh as compared with the same period of last year.

### SUSTAINABLE DEVELOPMENT

In the course of its rapid development, the Group proactively facilitated the development of the corporate governance of the Board. It kept enhancing the role of the Board and the management, whereby each had defined terms of reference and responsibilities, executed effective check and balance, and conducted rational decision-making, thus forming a corporate governance structure with high efficiency. The Group has always attached great importance to honesty & integrity management, and complied with laws and regulations, international practice, and business ethics. It has also insisted that the relationship among staff, suppliers, customers, relevant government authorities, partners, competitors, and other stakeholders shall be dealt with on an arm's length basis and in good faith, so as to gain market share and win respect with integrity and to improve the Company's inherent qualities and value with compliance management.

The Group also attaches great importance to environmental, social and governance (ESG) management, and has established an ESG working group under the leadership of the Board with the participation of all departments of the Group to promote the full implementation of the ESG sustainable development management system. We also continue to engage consulting firms to provide professional advice on the Group's ESG management system, policies, information disclosure, performance, and practice, and strive to further improve the Group's ESG performance. The Group believes that these measures in place will promote the Group's sustainable development and contribute to the construction of a better ecological environment. 二零二三年,本集團組織董事會成員及管 理層進行了反貪腐和環保方面的培訓,自 上而下深入強化學習廉政文化、增強環保 意識。年內,MSCI維持公司ESG評級A 級,本集團將通過務實、可查的ESG優質 管理舉措,獲得社會各界認可與肯定,將 國家2030碳達峰和2060碳中和的雙目標融 於日常經營管理,落於實質業務發展。

### 財務資料

本集團二零二三年實現營業額1,012.7億港 元,同比增長7.3%。本集團整體毛利率為 18.2%,較去年同期下跌1個百分點,整體 毛利率下跌主要是由於毛利率相對較高的 接駁收入佔比由去年同期的12.9%下降至 10.8%。本集團相信,未來收入結構將有持 續優化空間,本集團有信心未來保持高品 質可持續發展。

本集團一直採取審慎的財務資源管理政 策,將借貸及資本性開支控制在健康水 準。二零二三年,本集團經營性現金流為 101.6億港元,同比增長58.0億港元,經 營品質持續優化。本集團有足夠的資金及 可動用銀行信貸應付未來的資本性支出及 營運需要。基於本集團堅持穩健的業績品 質,年內,穆迪、標準普爾及惠譽繼續推 持本集團A2、A-、A-評級。該等評級反映 了本集團專注主業發力綜合服務及綜合能 源業務的發展戰略及當期的財務表現得到 了市場的廣泛認可,將保障本集團可獲得 較低的潛在融資的財務成本,為本集團長 期健康發展提供充足的財務資源。

### 誠信合規文化

During the year, MSCI maintained the Company's ESG rating of A. The Group will obtain recognition and affirmation from all walks of life through pragmatic and accountable ESG quality management measures, integrating the national dual goals of "peak carbon dioxide emissions target by 2030 and reach carbon neutrality by 2060" into daily operational management to achieve substantive business development.

### **FINANCIAL INFORMATION**

The Group achieved a turnover of HK\$101.27 billion in 2023, representing a year-on-year increase of 7.3%. Overall gross profit margin of the Group was 18.2%, representing a decrease of 1PPT as compared with that of last year. The decrease in overall gross profit margin was mainly due to the decrease in the share of revenue from gas connection with a higher gross profit margin from 12.9% the same period last year to 10.8%. The Group believes that revenue structure will continue to be optimised in the future, and the Group is optimistic that it will maintain high quality and sustainable development in the future.

The Group has been adopting prudent financial resources management policies to keep borrowings and capital expenditure at a sound level. In 2023, the Group's operating cash flow achieved HK\$10.16 billion, representing a year-on-year increase of HK\$5.80 billion and continuously optimising the operating quality. The Group has sufficient funds and available banking facilities to meet capital expenditures and operating requirements in the future. Given the Group's sustained in performance, Moody's, Standard & Poor's and Fitch maintained the credit rating of the Group at A2, A- and A- during the year. The ratings reflect the Group's development strategy of focusing on its core business comprehensive services and comprehensive energy and its financial performance for current period has been widely recognised by the market, which will further reduce the finance costs to be incurred by the Group in its potential financing activities, and provide sufficient financial resources for the long-term healthy development of the Group.

### **HONESTY & INTEGRITY CULTURE**

The Group always regards honesty & integrity as its foundation of development, and has issued and implemented a series of measures in recent years, including Regulation on Honesty & Integrity (《誠信合 規管理辦法》) and Rules for Staff Responsible for Honesty & Integrity Culture (《誠信合規專員工作制度》) and requires every staff to sign the Honesty & Integrity Declaration (《誠信合規宣言》).

### **CAPITAL MARKET PERFORMANCE**

From 2008 to 2023, the share price of the Group has increased by 7.5 times from HK\$3.4 to HK\$25.6 and its market capitalisation has increased by 19.2 times from HK\$3.08 billion to HK\$59.24 billion.

From 2008 to 2023, the profit of the Group increased by 21.8 times from HK\$240 million to HK\$5.22 billion, turnover increased by 33.9 times from HK\$2.99 billion to HK\$101.27 billion and total assets increased by 37.2 times from HK\$3.71 billion to HK\$137.87 billion.

Based on Bloomberg's report, as at 31st December, 2023, the Group was covered by 49 analyst reports.

Given the Group's robust performance, Moody's, Standard & Poor's and Fitch maintained the credit rating of the Group at A2, A- and A- in 2023. The ratings reflect the Group's development strategy of focusing on its core business comprehensive services and comprehensive energy and its financial performance for current period has been widely recognised by the market, which will further reduce the finance costs to be incurred by the Group in its potential financing activities, and provide sufficient financial resources for the long-term healthy development of the Group.

### **DEVELOPMENT PROSPECT**

In 2023, despite the complex and severe international environment and the arduous tasks of domestic reform, development and stability, China's economy rebounded well with steady improvement in supply and demand, economic transformation and upgrading were actively promoted, employment and commodity prices were generally kept stable, and people's livelihood was effectively safeguarded, advancing high-quality development steadily. In 2024, the government work report of the PRC proposed to actively and steadily promote the carbon peak and carbon neutrality, and solidly carry out the Top Ten Actions for Carbon Peak. At present, natural gas, as the cleanest and lowest-carbon fossil energy, is an indispensable and important

### 經營業績

於截至二零二三年十二月三十一日止年 度,本集團秉承追求卓越的進取精神,積 極應對多重超預期事件帶來的負面影響, 年內,本集團之營業額上漲7.3%至1,012.7 億港元。錄得本公司擁有人應佔溢利52.2 億港元,較去年同期上升10.4%。本公司的 經營溢利增加6.3%至92.1億港元,及經營 業務產生的現金由二零二二年的43.5億港 元增加至二零二三年的101.6億港元。

本集團的收入來自銷售及分銷氣體燃料及 相關產品、燃氣接駁、綜合服務、設計與 建設服務及加氣站,分別佔二零二三年收 入的81.6%、10.8%、4.0%、0.4%及3.2% (二零二二年:分別為79.6%、12.9%、 3.5%、0.5%及3.5%)。

燃氣總銷量由358.9億立方米增加8.1%至 387.8億立方米。

### **OPERATING RESULTS**

Active in pursuit of excellence, the Group reduced the negative impact of multiple events beyond expectation during the year ended 31st December, 2023. During the year, the Group's revenue increased by 7.3% to HK\$101.27 billion and we recorded profit attributable to the owners of the Company of HK\$5.22 billion, representing a increase of 10.4% over the previous corresponding period. The operating profit of the Company increased by 6.3% to HK\$9.21 billion and the cash generated from operations increased from HK\$4.35 billion in 2022 to HK\$10.16 billion in 2023.

The revenue of the Group was derived from sales and distribution of gas fuel and related products, gas connection, comprehensive services, design and construction services and gas stations, which respectively accounted for 81.6%, 10.8%, 4.0%, 0.4% and 3.2% of the revenue for 2023 (2022: 79.6%, 12.9%, 3.5%, 0.5% and 3.5%, respectively).

Gross gas sales volume increased by 8.1% from 35.89 billion  $m^3$  to 38.78 billion  $m^3.$

The total number of newly connected residential users in 2023 was 3.31 million.

In 2023, the Group continued to make new acquisitions and invested or paid HK\$1.65 billion in 11 city gas projects. Most of these projects are either wholly owned or majority owned by the Group.

### 精準學標桿

「學標桿」是一個將自身業務流程及績效指 標與業內最佳實踐者進行比較的過程。本 集團已在所有業務部門推行向最佳實踐者 學標桿舉措。「學標桿」已開始在集團內成 員公司間進行,並已拓展至與行業外部最 佳實踐者對標。

推行「學標桿」是華潤燃氣實現增長方式由 資源投入向效率提升這一根本轉變的必然 選擇,也是華潤燃氣確保達成戰略目標, 成為「中國第一、世界一流」燃氣企業的重 要舉措。

內部及外部學標桿活動相結合將有助於各 成員公司識別其現階段表現與其預期之間 的最重要差距,從而就作出改變而制訂詳 細計劃及嚴格的必要成本控制及表現基 準,以在削減成本及提升表現的同時有效 追蹤該詳細計劃的實施進度。所有成員公 司不僅須與總部簽署「學標桿責任合同」, 持續深化30項量化指標突出管理重點,使 對標更加精準。該持續學標桿活動於二零 二三年取得滿意的成績。 The investments will enable the Group to further extend its coverage and footprint in the PRC. The Group has existing city gas operations in these provinces and has 84 regional offices set up in various strategic locations in the PRC. The projects of the investments will be efficiently integrated and managed by the relevant regional office depending on their geographical locations. As such, the Group considers that the investments will create synergies with the Group's existing gas operation, thereby broadening the Group's revenue base as well as enhancing and sustaining its profitability.

The Group also conducts ongoing evaluation of past investments, which are essential for making decisions on future investments.

### PRECISE BENCHMARKING

"Benchmarking" is the process of comparing one's business processes and performance metrics to the best practices of the industry. The Group has implemented benchmarking initiatives from best practitioners in all business sectors. "Benchmarking" has started off internally with intra-group benchmarking and have extended to benchmarking against external best practices of the industry.

Implementing "Benchmarking" measure is an indispensable choice for CR Gas to accomplish the fundamental transformation of its growth model from resources-driven growth to efficiency improvement, and is also one crucial approach taken by CR Gas to achieve its strategic goal to become the leading world-class gas enterprise in China.

This combination of internal and external benchmarking helps each member company to identify the most important gaps between its current state and where it wants to be. It creates a road map for change and generates the rigorous cost and performance baseline necessary to effectively track progress on that road map over time in terms of cost reductions and performance improvements. All member companies were required to sign "Benchmarking Responsibility Contracts" with head office, and continued to deepen 30 quantitative benchmarks, highlighting the key objectives and becoming more focused and precise. This ongoing campaign has led to many satisfying results in 2023.

# 持續提高區域中心和設計及工 程中心效率

### CONTINUOUS EFFICIENCY IMPROVEMENT OF REGIONAL CENTRES AND DESIGN & CONSTRUCTION CENTRES

The Group has 84 regional centres to decentralise the management of the day to day operation of the Group's city gas projects across China. Each regional centre is responsible for the day to day operation of a cluster of cities within their respective regions. This enhances the operation efficiencies and provides better services that respond faster to changing local demand and conditions.

Members of the Group's management team concurrently serve as regional general managers. The arrangement minimises the increase in headcounts or resources, thereby achieving the goal of attaining maximum results with minimum resources.

The centralisation of the Group's design and construction activities will further enhance standardisation of pipeline construction and central procurements thereby resulting in further cost reductions.

# BUSINESS PROCESS STREAMLINING AND OPERATION ENHANCEMENT

The Group continued its systematic review of the business and management processes of its various city gas projects. This ongoing process is expected to continuously enhance the overall operational efficiency of city gas projects.

The Group's supply chain management was further streamlined with rigorous tender system covering construction projects, and the new or revised guidelines covering various categories of projects and quality control measures were issued and implemented. With the help of centralised procurement IT system, the procurement of most of our materials has been centralised, representing 90.14% of total material procurement expenditure up to the end of 2023. While safeguarding product quality, the Group reduced procurement costs through centralised procurement.

Improvements were also carried out on the employee recruitment, assessment, remuneration and staff retention policies to enhance the human resources management process with the objective of recruiting, promoting and retaining the best talents, from both internal and external sources. CR Gas's management team comprises utility professionals with significant expertise and experiences across financial, law, commercial and engineering disciplines. We strive to provide and maintain a satisfying and rewarding working environment for employees and commit to their training and professional development.

In view of the significant increase in operation size of the Group in recent years, we continued to promote the application of information technology systems covering project management, top-up cards for gas stations, office administration, centralised cash management, financial reporting, human resources, centralised procurement and customer service at various levels of the Group's operation, so as to improve our operational efficiency.

On the continuous enhancement of customer service, through continuously diversifying product portfolio, enhancing the success rate of household safety inspection, shortening user complaint processing time, promoting internet payment, quickening the response of user hotlines and other measures, the Company has optimised user experience to continuously increase user satisfaction.

除本集團內部成立的控制、防災及緊急恢 復程序外,本集團亦完全符合地方及國家 的相關環保法例及許可要求。 On the financial and tax management areas, the Group has successfully promoted value-oriented management system to each member company and thus effectively reduced costs and expenses. In particular, we further enhanced the centralisation of cash management with the inclusion of more member companies in the system with significant increase of cash pool size. By doing so, the Group has greatly reduced the overall cost of borrowing. Furthermore, various taxation rationalisation and reduction measures were taken to reduce tax exposure and speed up tax setoffs and refunds.

### SAFETY MANAGEMENT ENHANCEMENT

The Group has formulated a number of safety management policies and procedures, and has hired qualified engineers and technical staff as well, to manage and prevent any potential accidents in the Group's natural gas related facilities which may cause damage to the environment.

In addition to our internally commissioned control, hazard prevention and emergency recovery procedures, the Group have fully complied with the relevant local and national environmental protection regulations and licensing requirement.

為提升安全標準,本集團在全公司開展有 關安全及環保意識的宣傳活動,同時應用 大數據、智能化等新技術,探索燃氣智能 監控和調度管理,加強關鍵環節和重點隱 患治理。本集團持續開展安全審核,全年 完成74個區域公司的審核任務,共發現 5,031餘處安全隱患,並積極推動各級單位 整改。在二零二三年,本集團投入1.11億 港元,完成鑄鐵管網改造80公里。

本集團重視為員工及用戶提供安全操作程 序培訓。因此,本集團定期為相關員工舉 辦培訓及講座,註冊安全工程師培訓、累 計培訓37.28萬人次、有效規範員工安全行 為。對於最終用戶,本集團全面講解安全 操作程序,並定期安排講座及派發安全操 作手冊。 To improve our safety standard, the Group carried out a range of company-wide safety and environment conscious campaigns. Meanwhile, the Group applied new technologies such as big data and intelligence to explore intelligent monitoring and dispatch management of gas, so as to strengthen key aspect and potential defect treatment. The Group continued to carry out safety audit, completed auditing work for 74 regional companies throughout the year, discovered over 5,031 hidden safety hazards, and vigorously promoted the rectification of units at all levels. In 2023, the Group invested HK\$0.111 billion and completed the transformation of 80 km of cast iron pipeline.

The Group places emphasis on educating staff and users in respect of safety procedures. Accordingly, the Group regularly organized trainings and seminars for relevant staff, and the training for certified safety engineers, with an aggregate of 372,800 persons/times of training received which effectively regulated employees' safety behavior. For end users, explanations of safety procedures are given and regular seminars as well as distribution of brochures and booklets on safety are arranged.

In addition to the "Gas Faculty" in China Resources University, which designs courses and provides training programs to the Group's workforce, the Group also operates 5 regional training centres covering Eastern, Northern, Central, Southern and South-Western China. These centres are located in our regional centres of Wuxi, Jining, Zhengzhou, Fuzhou and Chengdu. Various types of management and technical trainings are conducted through the Group for different levels of staff to enhance their knowledge and skills. Improvements were also carried out on the employee recruitment, assessment, remuneration and staff retention policies to enhance the human resources management process with the objective of recruiting, promoting and retaining the best talents, from both internal and external sources. CR Gas's management team comprises utility professionals with significant expertise across financial, law, commercial and engineering disciplines. We strive to provide and maintain a satisfying and rewarding working environment for employees and commit to their training and professional development. The Group remunerates its employees based on their performance, work experience and the prevailing market wage level. Further, bonuses are granted to employees and incentive awards are made to employees based on merit and performance. The Group believes this will assist to attract and retain quality staff and at the same time encourage the employees to give their best performances.

本公司在全國設立6個審計中心,並持續推動區域公司完善審計及風控職能,針對本 集團及成員企業共計開展22次審核,涉及 領域包括運營,財務及工程採購,本集團 已修訂及發佈各種審計及風控管理指引, 組織開展重大風險治理及內控自查,全年 未發生系統性風險。

二零二三年本集團持續完善制度體系,推動內控信息化建設、統籌開展重大風險防控,全面開展內控監督檢查工作,構建了 「強內控、防風險、促合規」三位一體內部控制體系,有效發揮內控體系強基固本, 防控風險的作用,收住了不發生系統性和 重大風險底線,切實推動本集團高質量發展。

### **RISK MANAGEMENT**

The Group is constantly alert to the threats or uncertainties with negative consequences facing the industry and has been taking various measures to safeguard the Group's interest.

The system of annual and regular safety audit has been established continuously on all operating member companies of the Group to ensure compliance with national and local safety regulations.

The Company has set up 6 audit centers across the country and continued to promote regional companies to improve audit and risk control functions. A total of 22 audits were carried out at the Group and member company levels, covering areas such as operation, finance, and project procurement. The Group has revised and issued various audit and risk control management guidelines, organized major risk management and internal control self-investigation, and no systemic risks occurred throughout the year.

In 2023, the Group kept improving its institutional system, equipped its internal control system with information technologies, and took comprehensive measures to prevent and control major risks and to supervise and inspect how the internal control system worked, thereby setting up an internal control system that can strengthen internal control, prevent risks and promote compliance. By doing so, the Group made full use of the internal control system to safeguard its operations and control risks, prevented systemic and major risks from happening, and boosted the high-quality development of the Group.



# 環保及社會貢獻

本集團透過拓展較為清潔的天然氣業務支 持中國政府正在執行的環保政策。依照國 家十四五規劃及自身發展實際,參考本集 團二零二零年節能減排指標情況,制定緣 色低碳轉型發展主要目標。截至二零二三 年底,本集團二氧化碳排放強度、萬元營 業收入(可比價)綜合能耗、萬元增加值 (現價)綜合能耗較二零二零年底分別下降 50.17%、23.73%、10.60%。

本集團亦通過舉行慈善活動向社會做出貢 獻。成員公司在多地廣泛開展扶貧助困、 捐資助學、關愛特殊群體以及志願者活 動,年內積極為各類公益事業捐款捐物, 樹立了良好的企業形象。二零二三年,華 潤燃氣積極踐行可持續的慈善公益,用實 際行動助力和諧社會建設。全年,華潤燃 氣共計慈善捐贈總額:369.5萬港元,累計 志願服務人次:7.9萬人次。

# **ENVIRONMENT AND SOCIAL CONTRIBUTIONS**

The Group is supporting the ongoing green environmental policies of the PRC government by actively expanding our cleaner natural gas business. In accordance with the national 14th Five-Year Plan and the Group's own development status, and with reference to its energy conservation and emission reduction targets in 2020, the Group has formulated the major development targets for green and lowcarbon transformation. As of the end of 2023, the Group's carbon dioxide emission intensity, comprehensive energy consumption per RMB10,000 of revenue (comparable price) and the comprehensive energy consumption per RMB10,000 of added value (current price) decreased by 50.17%, 23.73% and 10.60% as compared with those at the end of 2020, respectively.

The Group also carried out charitable activities as token of measure to contribute to society. The Group's member companies conducted activities such as poverty alleviation, donation for education, caring for particular groups as well as volunteer services in a number of regions, making donation (including money and materials) for various public welfare undertakings during the year, thus building a reputable corporate image of the Group. In 2023, CR Gas vigorously implemented sustainable charity and public welfare undertakings, taking positive actions to help build a harmonious society. Throughout the year, CR Gas's total charitable donations amounted to HK\$3,695,000, with cumulative volunteer services of 79,000 persons/ times.

### 財務業績

本集團於二零二三年全年營業額為1,012.7 億港元(二零二二年:943.4億港元)。

城市燃氣分銷業務所貢獻税後但非控股權 益前溢利為70.6億港元(二零二二年:63.1 億港元)及本公司擁有人應佔溢利為52.2億 港元(二零二二年:47.3億港元)。

### 營業額

於二零二三年,本集團錄得供氣總量387.8 億立方米,增長8.1%。截至二零二三年十 二月三十一日止年度,華潤燃氣的營業額 由943.4億港元上升7.3%至1,012.7億港 元,主要因為年內本集團年內銷氣業務快 速發展,上游天然氣價格上漲。

本集團錄得本公司擁有人應佔溢利52.2 億港元,較去年同期的47.3億港元上升 10.4%。

### 毛利率

本集團整體毛利率為18.2%,較上一年度 同期下降1個百分點。整體毛利率下降主要 是由於年內本集團銷售及分銷氣體燃料及 相關產品收入及加氣站收入佔營業收入的 比例由去年的83.2%上升至二零二三年的 84.8%,而毛利率相對較高的接駁收入佔 比由去年的12.9%下降至10.8%。本集團相 信,未來收入結構將有持續優化空間,本 集團有信心未來保持高品質可持續發展。

### **FINANCIAL RESULTS**

The Group's annual revenue in 2023 amounted to HK\$101.27 billion (2022: HK\$94.34 billion).

The city gas distribution business contributed an after tax but before non-controlling interest profit of HK\$7.06 billion (2022: HK\$6.31 billion) and profit attributable to owners of the Company of HK\$5.22 billion (2022: HK\$4.73 billion).

#### Turnover

In 2023, the Group recorded a gross gas volume of 38.78 billion cubic meters, representing an increase of 8.1%. The turnover of CR Gas registered an increase of 7.3% from HK\$94.34 billion to HK\$101.27 billion for the year ended 31st December, 2023, mainly due to the rapid development of the Group's gas sales business during the year and the rise in the price of upstream natural gas.

The Group recorded profit attributable to the owners of the Company of HK\$5.22 billion, representing a increase of 10.4% as compared to HK\$4.73 billion for the previous corresponding period.

### **Gross Margin**

The Group's overall gross profit margin was 18.2%, representing a decrease of 1 percentage point as compared with that of last year. The decrease in overall gross profit margin was mainly because the revenue from the Group's sale and distribution of gas fuel and related products and revenue from gas stations as a percentage of operating revenue increased from 83.2% last year to 84.8% in 2023, while the percentage of revenue from gas connection with higher gross profit margin decreased from 12.9% last year to 10.8%. The Group believes that the revenue structure will continue to be optimised in the future, and the Group is optimistic of high-quality and sustainable development in the future.

### 其他收入、成本及開支

其他收入增加14.9億港元乃主要由於二零 二三年本集團實現重慶燃氣及廈門華潤燃 氣併表,產生一次性收益共計10.8億港元。

按佔收入百分比計算,銷售及分銷開支以 及行政費用分別佔比6.7%及4.5%(二零二 二年:分別為6.7%及4.1%)。

財務開支增加3.84億港元乃主要由於借貸 總額提升。

應佔合營公司業績增加港幣1.94億元,主 要由於合肥項目落地後帶來整年收益以及 天津項目經營改善。而應佔聯營公司業績 減少6,000萬港元,主要由於重慶燃氣於 2023年成為集團的附屬公司。

税項為18.5億港元,佔除税前溢利20.8% (二零二二年:26.8%)。

### 營運和自由現金流

城市燃氣分銷業務持續帶來穩健的現金 流,除税後經營現金流量淨額為101.6億 港元。本集團於二零二三年底的銀行結餘 及現金為99.8億港元。本集團已於二零二 三年繼續利用其良好的資產負債表籌集低 成本融資,截至二零二三年十二月三十一 日,貸款總額為265.3億港元。本集團維 持非常健康的資產負債表,總負債與總資 產的比率較低,為54.0%(二零二二年: 53.2%)。

#### 合理的回報率

由於本集團尚正處快速擴張階段,城市燃 氣分銷業務錄得算合理的股本回報率, 二零二三年為12.8%,較二零二二年增加 0.8ppt。本集團於二零二三年投資合計11 個新項目。待所有此等新收購項目在二零 二三年及往後開始達致更高經營效率及賺 取更高回報後,回報率將得以改善。

#### Other income, costs and expenses

The increase of HK\$1.49 billion in other income was mainly due to the fact that in 2023, 重慶燃氣 and 廈門華潤燃氣 were consolidated into the consolidated financial statements of the Group, resulting in a one-off gain of HK\$1.08 billion.

As a percentage of revenue, selling and distribution expenses as well as the administration expenses were 6.7% and 4.5% respectively (2022: 6.7% and 4.1%, respectively).

Finance expense increased by HK\$384 million was mainly due to the increase in total borrowing.

The increase in share of results of joint ventures by HK\$194 million was mainly due to the overall revenue brought by the launch of Hefei project and the improvement in the operation of Tianjin project. And the decrease in share of results of associates by HK\$60 million was mainly due to  $\pm p \pm k \pm 0$  become the Group's subsidiary in 2023.

Taxation amounted to HK\$1.85 billion, representing 20.8% of profit before taxation (2022: 26.8%).

#### Operating and free cash flow generation

The city gas distribution operation continued to bring in healthy cash flow with a net operating cash flow after tax of HK\$10.16 billion. The Group recorded bank balances and cash of HK\$9.98 billion at the end of 2023. The Group continued to leverage on its strong balance sheet to raise low cost finance during 2023 and had a total borrowings of HK\$26.53 billion outstanding as at 31st December, 2023. The Group maintains a very healthy balance sheet with a low gross debt to total asset ratio of 54.0% (2022: 53.2%).

### **Reasonable rates of return**

In view of the fact that the Group is still in expansion phase, the city gas distribution operation maintained reasonable return on equity of 12.8% in 2023, representing a increase of 0.8 percentage points from 2022. The Group invested a total of 11 new projects in 2023. The rates of returns were expected to improve once all these newly acquired projects started to attain higher operating efficiency and generated more returns in 2023 and thereafter.

### 帶來主要貢獻的項目

過往,逾80%的燃氣銷售量、接駁費用及 純利來自早期於二零零八年收購的成都、 無錫及蘇州項目。由於本集團於二零零九 年至二零二三年收購更多新項目,故彼等 帶來貢獻的比例減低,減低部份由重慶、 天津、寧波、鄭州、鎮江、福州、南京、 青島、合肥、安陽及武漢所取代。預期於 未來所有項目帶來貢獻的比例分佈將逐步 更為均匀。擴展本集團的盈利基礎將確保 本集團不會嚴重依賴任何單一的城市燃氣 項目。

### 流動資金和財務資源

年內,除税後經營業務現金流入淨額為 101.6億港元(二零二二年:43.5億港元)。

本集團於年內支出資本開支27.4億港元用 作收購擴充。本集團支出51.5億港元(二零 二二年:62.4億港元)提升及擴充其現有城 市燃氣管道和相關設施。上述所需資金乃 由本集團的經營現金流量、銀行借貸及庫 存現金撥付。於年終,本集團的銀行結餘 及現金以及其他存款為99.8億港元(二零二 二年:64.4億港元)。現金結餘中0.52%以 港元計值,99.45%以人民幣計值及0.03% 以美元計值。

本集團的資金政策為使用經營業務所得現 金流量及適當水平的借貸,作為主要擴展 及收購所需資金的主要來源。於年終,本 集團的借貸總額為265.3億港元(二零二二 年:224.6億港元),其中32.8%(二零二 二年:55.4%)的借貸總額列作流動負債, 須於一年內償還,而其餘則須於一年後償 還。人民幣、港元、美元及日圓貸款分別 佔借貸總額76.2%、14.8%、7.6%及1.4% (二零二二年:67.2%、24.5%、7.6%及 0.7%)。23.7%(二零二二年:30.9%)的借 貸總額按浮動利率計息及76.3%(二零二二 年:69.1%)為按固定利率計息的銀行貸款 及中期票據。

本集團於年終的銀行結餘及現金為99.8億 港元。本集團於年終的負債比率(按借貸 總額除以總資產計算)為19.2%(二零二二 年:20.0%)。本集團的財務及流動資金狀 況非常良好及穩健。

### **Major contributors**

Previously, the earlier projects of Chengdu, Wuxi and Suzhou acquired in 2008 used to account for more than 80% of the gas sales volume, connection fee and net profit contribution. As the Group acquired more new projects from 2009 to 2023, their contribution percentages decreased and were taken up by others such as Chongqing, Tianjin, Ningbo, Zhengzhou, Zhenjiang, Fuzhou, Nanjing, Qingdao, Hefei, Anyang and Wuhan. The percentage contribution from all projects were expected to gradually become more evenly distributed in the future. The broadening of the Group's earning base will ensure that the Group will not rely heavily on any single city gas project.

#### Liquidity and Financial Resources

The net cash inflow after tax from operations during the year amounted to HK\$10.16 billion (2022: HK\$4.35 billion).

To fund its acquisition expansion, the Group spent HK\$2.74 billion in capital expenditure during the year. The Group spent HK\$5.15 billion in upgrading and expanding of its existing city gas pipelines and related facilities (2022: HK\$6.24 billion). The above required funding was financed by the operating cash flow, bank borrowings and cash on hand of the Group. As at year end, the Group's bank balances and cash and other deposits was HK\$9.98 billion (2022: HK\$6.44 billion). Among the balances, 0.52% was denominated in Hong Kong dollar and 99.45% in Renminbi and 0.03% in US dollar.

It is the Group's policy to use the cash flow generated from operations and appropriate level of borrowings as the principal source of fund to finance major expansion and acquisition. As at the end of the year, the Group had total borrowings of HK\$26.53 billion (2022: HK\$22.46 billion). 32.8% (2022: 55.4%) of the total borrowings are considered as current liabilities and repayable within one year, and the remaining are repayable in more than one year. Renminbi, Hong Kong dollar, US dollar and Japanese Yen, denominated borrowings accounted for 76.2%, 14.8%, 7.6% and 1.4% of the total borrowings respectively (2022: 67.2%, 24.5%, 7.6% and 0.7%). 23.7% (2022: 30.9%) of total borrowings are interest bearing on floating rate terms and 76.3% (2022: 69.1%) are interest bearing bank loans and medium-term notes with fixed interest rate.

The bank balances and cash of the Group was HK\$9.98 billion as at the year end. The gearing ratio of the Group at the end of the year, calculated as total borrowings over total assets, was 19.2% (2022: 20.0%). The financial position and liquidity of the Group is very healthy and stable.

本集團總獲授規模達681.2億港元,其中人 民幣389.8億元、82.9億日元、5.2億美元 及203.3億港元(二零二二年:156.3億港 元、人民幣338.9億元、38.8億日元及2.2 億美元)於二零二三年至二零二四年到期的 銀行備用額。備用額為無抵押,並以浮動利 率計息。於年終,本集團已使用16%的港 元備用額(二零二二年:35%)、90%的人 民幣備用額(二零二二年:0%)及30%的日元 備用額(二零二二年:70%)。

除上文所述外,本集團並無其他已承諾借貸 備用額。在日常流動資金管理方面,為了維 持資金靈活彈性,本集團已獲銀行批出足夠 的無承諾短期備用額。

#### 資產抵押

於二零二三年十二月三十一日,本集團已抵 押銀行存款357.88百萬港元作為應付天然 氣供應商的貿易賬款的擔保。

### 物業、廠房及設備

截至二零二三年十二月三十一日止年度,本 集團的城市燃氣分銷業務於廠房、機器及設 備方面支出為115.2億港元,及於在建工程 方面支出為39.7億港元。

#### 或然負債

於二零二三年十二月三十一日,本集團並無 任何重大或然負債。

### 財務管理及庫務政策

本集團於香港總部的司庫負責本集團的財務 風險管理。本集團的庫務政策以管理利率及 外幣匯率波動風險為主要宗旨之一。本集團 的政策為不參與任何投機活動。

本集團大部分資產和負債均以港元、美元和 人民幣計值,而小部分以日元計值。本集 團預期在此方面不會面臨重大的外匯波動風 險。 The Group has been granted a total of HK\$68.12 billion, RMB38.98 billion, JPY8.29 billion, US\$0.52 billion and HK\$20.33 billion (2022: HK\$15.63 billion, RMB33.89 billion, JPY3.88 billion and US\$0.22 billion) banking facilities with maturities from 2023 to 2024. The facilities are unsecured and with floating interest rates. As at the end of the year, 16% of the HK\$ facilities (2022: 35%), 90% of the RMB facilities (2022: 7%), 99% of the US\$ facilities (2022: 0%) and 30% of the JPY facilities (2022: 70%) has been drawn down.

Other than the above, the Group has no other committed borrowing facilities. For day-to-day liquidity management and maintaining flexibility in funding, the Group has managed to obtain sufficient uncommitted short-term facilities from banks.

#### **Charge of Assets**

As at 31st December, 2023, bank deposits of HK\$357.88 million were pledged as securities for trade payables to suppliers of natural gas.

#### **Property, Plant and Equipment**

During the year ended 31st December, 2023, the Group's city gas distribution business spent HK\$11.52 billion on plant, machinery and equipment and HK\$3.97 billion on construction in progress.

#### **Contingent Liabilities**

As at 31st December, 2023, the Group did not have any material contingent liabilities.

#### **Financial Management and Treasury Policy**

The financial risk management of the Group is the responsibility of the Group's treasury function at the head office in Hong Kong. One of the major objectives of the Group's treasury policies is to manage its exposure to fluctuation in interest rates and foreign currency exchange rates. It is the Group's policy not to engage in speculative activities.

Most of the Group's assets and liabilities are denominated in Hong Kong dollar, US dollar and Renminbi with some denominated in JPY. The Group does not expect significant exposure to foreign exchange fluctuations in this regard.

守則條文C.3.3規定,本公司應有正式的董 事委任書,訂明有關彼等委任的主要條款 及條件。本公司並沒有向董事發出正式的 委任書,惟彼等須根據細則至少每三年輪 值退任一次。再者,董事須參考由公司註 冊處出版之《董事責任指引》及由香港董事 學會出版之《董事指引》及《獨立非執行董事 指南》(如適用)中列明之指引履行彼等作為 董事之職責及責任。而且,董事亦須遵守 法規及普通法之要求、上市規則、法律及 其他監管要求及本公司之業務及管治政策。 The Group is dedicated to maintaining a good credible framework of corporate governance with a view to being transparent, open and accountable to its shareholders.

# COMPLIANCE WITH CORPORATE GOVERNANCE CODE

The Company has adopted the mandatory provisions of the Corporate Governance Code (the "Code") set out in Part 2 of Appendix C1 (formerly Appendix 14) to the Rules Governing the Listing of Securities on the Stock Exchange ("Listing Rules"). In line with the mandatory provisions of the Code, the Company adopted a Corporate Governance Handbook (the "Handbook") on 23rd December, 2005 and subsequently updated it from time to time. The contents of the Handbook include, among others, directors' duties, model code for directors' transactions in securities, model code for securities transactions by relevant employees, the functions and terms of reference of the Audit and Risk Management, Remuneration, Nomination and Corporate Governance Committees of the Company (each "Audit and Risk Management Committee", "Remuneration Committee", "Nomination Committee" and "Corporate Governance Committee"), disclosure of information, communication with shareholders, procedures for shareholders to propose a person for election as a director and Board diversity policy. All the mandatory provisions under the Code have been adopted and reflected in the Handbook. The Company has throughout the year complied with the mandatory provisions of the Code except for the deviation from the code provisions C.3.3 and F.2.2 which is explained as follows:

Under the code provision C.3.3, the Company should have formal letters of appointment for directors setting out the key terms and conditions of their appointment. The Company did not have formal letters of appointment for Directors. However, the Directors are subject to retirement by rotation at least once every three years in accordance with the Bye-Laws. In addition, the Directors are required to refer to the guidelines set out in "A Guide on Directors' Duties" issued by the Companies Registry and "Guidelines for Directors" and "Guide for Independent Non-executive Directors" (if applicable) published by the Hong Kong Institute of Directors in performing their duties and responsibilities as Directors. Besides, the Directors are required to comply with the requirements under statute and common law, the Listing Rules, legal and other regulatory requirements and the Company's business and governance policies.

The names and biographical details of each Director are disclosed on pages 29 to 37 of this annual report.

Each Independent Non-executive Director has, pursuant to the guidelines set out in rule 3.13 of the Listing Rules, confirmed that he is independent of the Company and the Company also considers that they are independent. The term of office of each Non-executive Director, including Independent Non-executive Director, is for a period of three years subject to the requirement that one-third of all the Directors shall retire from office by rotation at each annual general meeting pursuant to the Bye-Laws of the Company. The relationship (including financial, business, family or other material/relevant relationship), if any, among members of the Board are disclosed in this annual report. There is no such relationship between the Chairman and the Chief Executive Officer.

Mr. LI Pok Yan, Ms. GE Lu, and Mr. LI Xiaoshuang, being Directors of the Company appointed during 2023, obtained the legal advice referred to in Rule 3.09D of the Listing Rules on 20th October, 2023, 26th October, 2023 and 14th December, 2023 respectively, and each of them has confirmed he/she understood his/her obligations as a Director of the Company.

# **FUNCTIONS**

The Board is responsible both for how the Company is managed and the Company's direction. Approval of the Board is required for the strategy of the Group, yearly budget, major acquisition and disposal, major capital investment, dividend policy, appointment and removal of Directors and senior management, remuneration policy and other major operational, financial, risk management and internal control matters. Day-to-day operations of the Group are the responsibility of the Company's management.

#### **Summary of the Policy**

The Company sees diversity at Board level as an essential element in maintaining a competitive advantage. A truly diverse Board will include and make good use of differences in the skills, regional and industry experience, background, gender and other qualities of the members of the Board. These differences will be considered in determining the optimum composition of the Board and when possible should be balanced appropriately. All Board appointments are made on merit, in the content of the skills and experience the Board as a whole requires to be effective.

#### 執行

#### Measurable Objectives

The Nomination Committee will discuss and agree annually all measurable objectives for achieving diversity on the Board and recommend them to the Board for adoption. At any given time, the Board may seek to improve one or more aspects of its diversity and measure progress accordingly. For the year under review, no measurable objective was set by the Nomination Committee.

As at the end of 2023, the Company has 58,608 employees in total comprising of approximately 19,341 females and 39,267 males (a female-to-male ratio of 2:1), reflecting a gender equality principle generally adhered to by the Company. The Company is mindful of the objectives as set out in the diversity policy when assessing the candidacy of the employees, and will ensure that the Company shall continue to follow the policy. To achieve gender diversity in the Board, the Company has appointed one female Director during 2023 to comply with the requirements of the Listing Rules.

The Board will annually review the implementation and effectiveness of the Board diversity policy. The Board considers that the policy is effective to achieve diversity at the Board.

The Board will review the implementation and effectiveness of such mechanisms on an annual basis.

The Board considers that the above mechanisms are effective in ensuring that independent views and input are provided to the Board.

# CHAIRMAN AND THE CHIEF EXECUTIVE OFFICER

As at the date of this annual report, the Chairman of the Board is Mr. WANG Chuandong while Mr. YANG Ping is the Chief Executive Officer. The Chairman provides leadership to the Board and formulate, together with the Board, the business strategies and long-term objectives of the Company whilst the Chief Executive Officer carries out the decisions made by the Board and is in charge of the Company's day-to-day management.

#### **BOARD COMMITTEES**

To strengthen the functions of the Board and to enhance its expertise, as at the date of this annual report, there are five committees namely, the Audit and Risk Management, Remuneration, Nomination, Investment and Corporate Governance Committees under the Board, with each performing different functions.

#### Audit and Risk Management Committee

As at the date of this annual report, the Audit and Risk Management Committee comprises of three Independent Non-executive Directors namely Mr. YU Hon To, David (Chairman), Mr. WONG Tak Shing and Mr. YANG Yuchuan and one Non-executive Director, namely Mr. LIU Jian. The Committee's role is to provide an independent and objective review of the effectiveness of the financial reporting process, internal control, risk management as well as internal audit function of the Group. Its functions broadly fall into the following three main areas:

- make recommendations to the Board on the appointment, reappointment and removal of external auditor, and to approve the remuneration and terms of engagement of external auditor and any matters related to the resignation or dismissal of external auditor;
- review the financial statements of the Company's annual and half-year reports and accounts;

In identifying suitable candidates for appointment to the Board, the Nomination Committee will consider candidates on merit against objective criteria and with due regard for the benefits of diversity on the Board. Any committee member may propose suitable candidates for directorship for discussion and approval by the Nomination Committee, after which the Board will consider and, if proper, approve such nomination. Directors thus selected is subject to re-election by shareholders of the Company in the next general meeting or next annual general meeting, as appropriate, according to the Bye-Laws of the Company.

#### 提名政策

#### **Nomination Policy**

Nomination policy aims to ensure that the Board has a balance of skills, experience, knowledge and diversity of perspectives appropriate to the requirements of the Company's business.

The Nomination Committee will evaluate, select and recommend candidate(s) for directorships to the Board by giving due consideration to criteria including but not limited to (collectively, the "Criteria"):

- (a) Diversity in aspects including but not limited to gender, age, cultural and educational background, professional experience, skills, knowledge and length of service;
- (b) Commitment for responsibilities of the Board in respect of available time and relevant interest;
- Accomplishment and experience in the relevant industries in which the Company's business is involved and other professional qualifications;
- (d) Reputation for integrity;
- Potential contributions that the individual(s) can bring to the Board;
- (f) Plan(s) in place for the orderly succession of the Board.

The above Criteria are for reference only, and not meant to be exhaustive and decisive. The Nomination Committee has the discretion to nominate any person, as it considers appropriate.

The Nomination Committee will evaluate and recommend retiring Director(s) to the Board for re-appointment by giving due consideration to the criteria including but not limited to:

- (a) The overall contribution and service of the retiring Director(s) to the Company, including but not limited to the attendance of the meetings of the Board and/or its committees and general meetings where applicable, in addition to the level of participation and performance on the Board and/or its committees;
- (b) Whether the retiring Director(s) continue(s) to satisfy the Criteria.

#### **Procedures and Process for Nomination of Directors**

- (a) The Nomination Committee may consult any source it deems appropriate in identifying or selecting suitable candidates, such as referrals from existing Directors, advertising, recommendations from third-party agency firm and proposals from shareholders of the Company with due consideration given to the Criteria;
- (b) The Nomination Committee may adopt any process it deems appropriate in evaluating the suitability of the candidates, such as interviews, background checks, presentations and third party reference checks;
- (c) The proposed candidates will be asked to submit the necessary personal information and biography for the Nomination Committee's consideration. The Nomination Committee may request the candidate(s) to provide additional information and documents, if considered necessary;
- (d) Upon considering a candidate suitable for the directorship, the Nomination Committee will hold a meeting and/or by way of written resolutions to, if thought fit, approve the recommendation to the Board for appointment;

- (e) The Nomination Committee will provide the relevant information of the selected candidate to the remuneration committee of the Company (the "Remuneration Committee") for consideration of remuneration package of such selected candidate;
- (f) The Nomination Committee will thereafter make the recommendation to the Board in relation to the proposed appointment, and where a non-executive Director is considered, the Remuneration Committee will make the recommendation to the Board on the proposed remuneration package;
- (g) The Board may arrange for the selected candidate to be interviewed by the members of the Board who are not members of the Nomination Committee and the Board will thereafter deliberate and decide the appointment as the case may be;
- (h) All appointment of Directors will be confirmed by the filing of the prescribed form with the Companies Registry of Hong Kong and updating (and, if necessary, filing) of the Register of Directors of the Company.

#### **Investment Committee**

The role and main function of the Investment Committee is to assist the Board in making investment decisions (including acquisition or divestment opportunity) within the investment threshold of US\$8 million to US\$20 million or other thresholds as authorised by the Board from time to time.

The Investment Committee comprised of three Non-executive Directors namely Mr. WANG Chuandong (Chairman), Mr. WANG Gaoqiang and Mr. HE Youdong, and one Independent Non-executive Director namely Mr. WONG Tak Shing.

The Investment Committee was dissolved and discharged on 25th August, 2023.

# 風險管理及內部監控

審核與風險管理委員會應董事會的委派或主 動就有關風險管理及內部監控事宜的重要 調查結果及管理層對調查結果的回應進行研 究。

審核與風險管理委員會亦考慮本公司會 計、財務申報和內部審核職能以及與本公司 ESG表現和匯報相關的資源、資格和經驗 及彼等的培訓計劃和預算是否充足。就處理 及發佈內幕消息的程序及內部監控而言,本 公司已制定有關處理內幕消息的書面政策及 程序,包括但不限於確保符合披露要求的措施。

內部審核部協助審核與風險管理委員會檢 討現行風險管理及內部監控系統運作的效 能。該部門定期進行內部審核及其他相關的 審計審核,並向審核與風險管理委員會報告 所得結果及提供內部監控的改良建議,以供 審核與風險管理委員會考慮。年內,內部 審核部亦曾對本公司主要風險管理系統進 行檢討,並向審核與風險管理委員會報告 所得結果以供考慮,且作為日後進一步改 進的基礎。在經營環境(特許權的有效性及 其保護、管道基礎設施瓶頸、策略執行障 礙等);財務管理(現金保管及管理、付款 審批程序、應收款管理、會計政策遵守情 況等);安全管理(管道基礎設施檢查及維 護程序、安全體系及相關安全事故匯報架構 等);工程及建設管理(投標程序審閱、項 目管理程序及常規);關鍵材料採購(賣方 及材料資格審核程序、投標及質量控制程序 等)等關鍵風險領域進行檢查及風險評估。

# **RISK MANAGEMENT AND INTERNAL CONTROL**

The Board has the overall responsibility of maintaining an effective risk management and internal control system to provide reasonable, though not absolute, assurance against material misstatement or loss and to manage rather than eliminate the risk of failure to achieve business objectives. The above risks include, but are not limited to, material risks related to ESG.

The Board, through the Audit and Risk Management Committee, conducts annual review of the effectiveness of the Company's systems of risk management and internal control covering all material controls, including financial controls, internal control and risk management systems.

The Audit and Risk Management Committee considers the major investigation findings on risk management and internal control matter as delegated by the Board or on its own initiative and management's response to these findings.

The Audit and Risk Management Committee also considers the adequacy of resources, qualifications and experience of the Company's accounting, financial reporting and internal audit functions as well as those relating to the Company's ESG performance and reporting, and their training programmes and budget. With respect to procedures and internal controls for handling and dissemination of inside information, the Company has set out written policies and procedures in relation to the handling of inside information, including but not limited to measures to ensure compliance of disclosure requirement.

The Internal Audit Division assists the Audit and Risk Management Committee to review the effectiveness of such risk management and internal control system in operation. The Division regularly carries out internal audit and other related audit reviews and reports its findings and suggestions for improvement on better internal controls to the Audit and Risk Management Committee for their consideration. During the year, the Internal Audit Division also conducted reviews of key risk management system of the Company. Its findings were reported to the Audit and Risk Management Committee for consideration and would form the basis for further improvement in the future. Inspections and risk assessments were carried out in key risk areas such as operation environment (concession rights availability and their protection, pipeline infrastructure bottlenecks, strategy execution hurdles, etc); financial management (cash custody and management, payment approval process, receivables management, accounting policy adherence, etc); safety management (pipeline infrastructure inspection and maintenance process, safety system and related safety incident reporting structure, etc); engineering and construction management (tender process reviews, project management procedures and practice); key materials procurement (vendor and materials qualification process, tendering and quality control processes, etc).

此外,內部審計部亦密切跟進所有業務單 位的糾正行動或其對關鍵風險領域的自我 檢查。

本公司已採納反貪污政策及反賄賂,以規 管員工接受利益,並已採納舉報政策,就 員工及外部相關人士舉報關於本集團任何 可能或真實不當行為提供指引。

Based on the results of the annual review, the Board is satisfied with the effectiveness of risk management and internal control system currently put in place for the Company.

#### SHAREHOLDERS' RIGHTS

#### Procedures for shareholders to convene special general meeting

In accordance with the Section 74 of the Companies Act 1981 of Bermuda ("Companies Act"), the shareholders of the Company holding at the date of the deposit of the requisition not less than one-tenth of such of the paid-up capital of the Company carrying the right of voting at general meetings of the Company, shall have the right to convene a special general meeting of the Company. If the directors do not within twenty-one days from the date of the deposit of the requisition proceed duly to convene a meeting, the requisitionists representing more than one half of the total voting rights may themselves convene a meeting.

The written requisition for the special general meeting can be lodged at the Company's principal office in Hong Kong at Room 1901-02, China Resources Building, 26 Harbour Road, Wanchai, Hong Kong.

# Procedures for shareholders to put forward proposals at a general meeting

Pursuant to the Sections 79 and 80 of the Companies Act, either any number of the registered shareholders holding not less than one-twentieth (5%) of the paid-up capital of the Company carrying the right of voting at general meetings of the Company ("Requisitionists"), or not less than 100 of such registered shareholders, can request the Company in writing to (a) give to shareholders entitled to receive notice of the next general meeting notice of any resolution which may properly be moved and is intended to be moved at that meeting; and (b) circulate to shareholders entitled to have notice of any general meeting any statement of not more than 1,000 words with respect to the matter referred to in any proposed resolution or the business to be dealt with at that meeting.

The requisition signed by all the Requisitionists may consist of several documents in like form, each signed by one or more of the Requisitionists; and it must be deposited at the Registered Office with a sum reasonably sufficient to meet the Company's relevant expenses, not less than six weeks before the meeting in case of a requisition requiring notice of a resolution or not less than one week before the meeting in the case of any other requisition. Provided that if an AGM is called for a date six weeks or less after the requisition has been deposited, the requisition though not deposited within the time required shall be deemed to have been properly deposited for the purposes thereof.

Pursuant to bye-law 113 of the Bye-Laws of the Company, the Company may from time to time in general meeting by ordinary resolution elect, or authorize the Directors to elect or appoint, any person to be a Director either to fill a vacancy or to act as an additional Director up to the maximum number of Directors determined by the members in general meeting.

Pursuant to bye-law 115 of the Bye-Laws of the Company, no person, other than a retiring Director, shall, unless recommended by the Board for election, be eligible for election to the office of Director at any general meeting, unless notice in writing of the intention to propose that person for election as a Director and notice in writing by that person of his willingness to be elected shall have been given to the Company provided that the minimum length of the period, during which such notices are given, shall be at least seven days. The period for lodgment of such notices will commence no earlier than the day after the dispatch of the notice of the meeting appointed for such election and end no later than seven days prior to the date of such meeting.

The detailed procedures regarding the election are published on the Company's website under Corporate Governance section.

#### **CONSTITUTIONAL DOCUMENTS**

During the year ended 31st December, 2023, there were no changes in the Company's Memorandum of Association and Bye-Laws. The latest version of the Memorandum of Association and New Bye-Laws of the Company is available on the websites of the Company and the Stock Exchange.

#### **Investor Relations**

The Board has adopted a Shareholder's Communication Policy on 30th December, 2022 which sets out the Group's commitment of maintaining an effective ongoing dialogue with shareholders. In summary, the Company establishes different communication channels with shareholders and stakeholders including: (i) provision of printed copies of corporate communications; (ii) provision of timely corporate information on the company website; (iii) holding of annual general meetings to provide platform for shareholders to raise comments and exchange views with the Board; and (iv) arrangement in serving the shareholders in respect of all share registration matters. The Board, through the Corporate Governance Committee, reviewed the validity of implementation of the Shareholder's Communication Policy during the year and considered that it remained effective in enhancing timely, transparent, accurate and open communication between the Company and the shareholders.

### 長期獎勵計劃

#### LONG TERM AWARD SCHEME

On 1st December, 2008, the Company adopted a share repurchased cash award scheme (the "Incentive Award Scheme"), pursuant to which selected employees of the Group or investee companies (being any company in which the Company directly or indirectly owns 5% or more attributable equity interests (the "Investee Company"), and in calculating the percentage interest so attributed, the percentage interest held in the Investee Company shall be multiplied by the percentage interest in each level of entity through which such interest is held by the Group), are entitled to participate in the Incentive Award Scheme pursuant to the scheme rules.

The purpose of the Incentive Award Scheme is to recognise and motivate the contribution of certain employees and to provide incentives and to enable the Group and the Investee Company in retaining their existing employees and recruiting additional employees and to provide them with a direct economic interest in attaining the long-term business objectives of the Company. Unless early termination by the Board, the Incentive Award Scheme shall be valid and effective for a term of 10 years commencing on the adoption date. The maximum aggregate numbers of award shares which can be awarded under the Incentive Award Scheme and to a selected employee throughout its duration are limited to 5% and 0.5% of the issued share capital of the Company from time to time respectively.

Pursuant to the rules of the Incentive Award Scheme, the Company has appointed BOCI-Prudential Trustee Limited as trustee (the "Trustee"), pursuant to which existing shares will be purchased by the Trustee from the market out of cash contributed by the Group and be held in trust for the relevant selected employees until such shares are vested with the relevant selected employees in accordance with the provisions of the Incentive Award Scheme. A total of 70,000,000 shares were purchased at an aggregate cost of approximately HK\$253,534,680 (including transaction costs) on 7th April, 2009, representing approximately 4.95% of the issued share capital of the Company as at date of acquisition. The Company does not intend to purchase any further share under the Incentive Award Scheme.

On 16th March, 2010, the Company amended the Incentive Award Scheme such that cash instead of award shares will be awarded under the Incentive Award Scheme (the "Scheme"). The Company will utilize the proceeds generated from disposal of the award shares held by the Trustee for the awards made under the Scheme. Pursuant to the approval of a special resolution at the special general meeting of the Company on 30th May, 2011, the amount of HK\$7,388,600,000 standing to the credit of share premium has been transferred to the contributed surplus. The contributed surplus is a distributable reserve and will be used for the payment of dividends and for such other purposes as allowed by the Companies Act 1981 of Bermuda. For the year ended 31st December, 2023, the amount of HK\$2,381,626,000 (for the year ended 31st December, 2022: HK\$2,880,633,000) has been used for the payment of dividends.
- b. The capital reserve arose from the difference between the amount by which the non-controlling interests are adjusted and the consideration paid/received for the acquisition/disposal of interests in subsidiaries.
- c. Other reserves comprise the changes in fair value of equity instruments designated at fair value through other comprehensive income, general reserve, statutory surplus reserve, enterprise expansion fund, statutory public welfare fund and discretionary surplus reserve of subsidiaries established in the People's Republic of China (the "PRC"), and the changes in net assets attributable to the Group in relation to the increase in ownership interests in subsidiaries through capital contribution.

The general reserve is appropriated each year on the basis of 5% to 10% of the profit after taxation of certain subsidiaries as determined by their boards of directors in accordance with the articles of association of the subsidiaries. This reserve should only be used for making up losses, capitalisation into capital and expansion of production and operation.

- d. The merger reserve represented the difference between (i) the cash consideration paid, deemed distribution to a fellow subsidiary and shares issued by the Company; and (ii) the amount of issued capital and premium of the combined entities under group reorganisations.

### 1. 一般資料

本公司為一家於百慕達註冊成立的獲 豁免的上市有限公司,其股份於香港 聯合交易所有限公司(「聯交所」)上 市,其中間母公司為於香港註冊成立 的華潤(集團)有限公司(「華潤集團公 司」);而其最終控股公司為中國華潤 有限公司(「中國華潤」),該公司為一 家於中國成立的公司。本公司註冊辦 事處及主要營業地點的地址於本年報 內公司資料一節披露。

本公司為一家投資控股公司,其主要 附屬公司、合營公司及聯營公司的業 務分別載於附註47、48及49。

綜合財務報表以港元(「港元」)呈列, 原因為本公司為一家股份於香港聯交 所上市的上市公司,而其大部分投資 者亦在香港,因此本公司董事認為在 呈列本公司及其附屬公司(統稱「本集 團」)經營業績及財務狀況時使用港元 更為合適。

#### 2. 編製基準

於編製本綜合財務報表時,有見 及於二零二三年十二月三十一日 本集團的流動負債超逾其流動資產 15,655,135,000港元及本集團有資本 承擔436,775,000港元,本公司董事 已審慎考慮本集團的未來流動資金狀 況。於二零二三年十二月三十一日, 本集團的銀行及其他借貸及中期票 據合共22,723,798,000港元,其中 4,892,674,000港元被分類為流動負 債。

本公司董事認為,經計及本集團未動 用的銀行融資21,845,964,000港元 及內部產生資金,本集團有充足營運 資金可滿足二零二三年十二月三十一 日起計未來十二個月的現時需求。因 此,本綜合財務報表以持續經營基准 予以編製。

#### 1. GENERAL

The Company is a listed public company incorporated in Bermuda as an exempted company with limited liability and its shares are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The Company's intermediate parent company is China Resources (Holdings) Company Limited ("CRH"), a company incorporated in Hong Kong, and its ultimate holding company is China Resources Company Limited ("CRCL"), a company established in the PRC. The addresses of the registered office and principal place of business of the Company are disclosed in the Corporate Information of the annual report.

The Company is an investment holding company. The activities of its principal subsidiaries, joint ventures and associates are set out in notes 47, 48 and 49, respectively.

The consolidated financial statements are presented in Hong Kong dollars ("HK\$") as the Company is a public company with its shares listed on the Stock Exchange in Hong Kong where most of its investors are located, and therefore, the directors of the Company consider that HK\$ is preferable in presenting the operating results and financial position of the Company and its subsidiaries (collectively referred to as the "Group").

#### 2. BASIS OF PREPARATION

In preparing the consolidated financial statements, the directors of the Company have given careful consideration to the future liquidity of the Group in light of the fact that the Group's current liabilities exceeded its current assets by HK\$15,655,135,000, and the Group had capital commitments of HK\$436,775,000 as at 31st December, 2023. As at 31st December, 2023, the Group had bank and other borrowings and medium-term notes totalling of HK\$22,723,798,000, of which HK\$4,892,674,000 was classified as current liabilities.

The directors of the Company are of the opinion that, taking into account of the unutilised banking facilities of HK\$21,845,964,000 and internally generated funds of the Group, the Group has sufficient working capital for its present requirements for the next twelve months from 31st December, 2023. Accordingly, the consolidated financial statements have been prepared on a going concern basis.

## 合規聲明

本綜合財務報表乃根據所有適用的香 港財務報告準則編製,此統稱包括香 港會計師公會所頒佈的所有適用的個 別香港財務報告準則、香港會計準則 及詮釋以及香港公司條例的披露規 定。本綜合財務報表亦遵守聯交所證 券上市規則的適用披露條文。本集團 採納的重大會計政策披露如下。

## 綜合財務報表的編製基準

截至二零二三年十二月三十一日止年 度的綜合財務報表包括本公司及其附 屬公司以及本集團於聯營公司及合營 公司的權益。

除於各個報告期末按公平值計算的若 干金融工具外,綜合財務報表乃根據 歷史成本基準編製,已在下列會計政 策中作出解釋。

歷史成本一般以交換貨品及服務時給 予代價的公平值為基準。

公平值是於計量日期市場參與者於有 秩序交易中出售資產可收取或轉讓負 債須支付的價格,而不論該價格是否 直接可觀察或可使用其他估值技術估 計。若市場參與者於計量日期對資產 或負債定價時會考慮資產或負債的特 點,則本集團於估計資產或負債的公 平值時會考慮該等特點。此等綜合財 務報表中作計量及/或披露用途的公 平值乃按此基準釐定,惟屬於香港財 務報告準則第2號「以股份為基礎的付 款」(「香港財務報告準則第2號」)範圍 的以股份付款的交易、屬於香港財務 報告準則第16號「租賃」範圍內的租 賃交易,以及與公平值有部分相若地 方但並非公平值的計量,譬如香港會 計準則第2號「存貨」內的可變現淨額 或香港會計準則第36號「資產減值」 的使用價值除外(「香港會計準則第36 號」)。

## 4. MATERIAL ACCOUNTING POLICIES

### Statement of compliance

These consolidated financial statements have been prepared in accordance with all applicable HKFRSs, which collective term includes all applicable individual HKFRS, HKAS and Interpretations issued by the HKICPA and the disclosure requirements of the Hong Kong Companies Ordinance. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange. Material accounting policies adopted by the Group are disclosed below.

#### Basis of preparation of the consolidated financial statements

The consolidated financial statements for the year ended 31st December, 2023 comprise the Company and its subsidiaries and the Group's interest in associates and joint ventures.

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments which are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for sharebased payment transactions that are within the scope of HKFRS 2 Share-based payment ("HKFRS 2"), leasing transactions that are within the scope of HKFRS 16 Leases, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 Inventories or value in use in HKAS 36 Impairment of assets ("HKAS 36").

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

## **Basis of consolidation**

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved where the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

When the Group has less than a majority of the voting rights of an investee, it has power over the investee when the voting rights are sufficient to give it the practical ability to direct the relevant activities of the investee unilaterally. Generally, there is a presumption that the majority of voting rights results in control. The Group considers all relevant facts and circumstances in assessing whether or not the Group's voting rights in an investee are sufficient to give it power, including:

- the size of the Group's holding of voting rights relative to the size and dispersion of holdings of the other vote holders;
- potential voting rights held by the Group, other vote holders or other parties;
- rights arising from other contractual arrangements; and
- the current ability to direct the relevant activities at the time that decisions need to be made, including voting patterns at previous shareholders' meetings.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the noncontrolling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the noncontrolling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

# Changes in the Group's ownership interests in existing subsidiaries

Changes in the Group's ownership interests in existing subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's relevant components of equity and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries, including re-attribution of relevant reserves between the Group and the non-controlling interests according to the Group's and the noncontrolling interests' proportionate interests.

Any difference between the amount by which the non-controlling interests are adjusted after re-attribution of the relevant equity component, and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

並非合併共同控制業務的收購業務採 用收購法入賬。業務合併中之轉讓代 價按公平值計量,而計算方法為本集 團所轉讓資產、本集團自被收購方原 股東承接之負債及本集團為交換被收 購方之控制權而發行之股權於收購當 日之公平值總額。有關收購之成本通 常於產生時於損益中確認。

當所收購的一組活動及資產包括對共 同創造產出能力作出重大貢獻的資源 投入及一項實質過程,本集團認為其 已收購一項業務。

## **Business combinations**

Acquisitions of businesses that are not combinations of business under common control are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognised at their fair value at the acquisition date, except that:

- deferred tax assets or liabilities, and assets or liabilities or assets related to employee benefit arrangements are recognised and measured in accordance with HKAS 12 *Income taxes* and HKAS 19 *Employee benefits* respectively;
- liabilities or equity instruments related to share-based payment arrangements of the acquiree or share-based payment arrangements of the Group entered into to replace share-based payment arrangements of the acquiree are measured in accordance with HKFRS 2 at the acquisition date; and
- assets (or disposal groups) that are classified as held for sale in accordance with HKFRS 5 *Non-current assets held for sale and discontinued operations* are measured in accordance with that standard.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net amount of the identifiable assets acquired and the liabilities assumed as at acquisition date. If, after re-assessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the relevant subsidiary's net assets in the event of liquidation are initially measured at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets or at fair value. The choice of measurement basis is made on a transaction-by-transaction basis. Other types of non-controlling interests are measured at their fair value.

# Merger accounting for business combinations involving entities under common control

The consolidated financial statements incorporate the financial statements items of the combining entities or businesses in which the common control combination occurs as if they had been combined from the date when the combining entities or businesses first came under the control of the controlling party.

The net assets of the combining entities or businesses are consolidated using the existing book values from the ultimate controlling parties' perspective. No amount is recognised in respect of goodwill or excess of acquirer's interest in the net fair value of acquiree's identifiable assets, liabilities and contingent liabilities over cost at the time of common control combination, to the extent of the continuation of the controlling party's interest.

The consolidated statement of comprehensive income includes the results of each of the combining entities or businesses from the earliest date presented or since the date when the combining entities or businesses first came under the common control, where this is a shorter period and up to the date of disposal, as appropriate.

The comparative amounts in the consolidated financial statements are restated as if the entities or businesses had been combined at the previous reporting period or when they first came under common control, whichever is shorter and up to the date of disposal, as appropriate.

就減值測試而言,商譽會分配至預期 會從合併獲得協同效益的本集團各現 金產生單位(或現金產生單位組別), 而該單位或單位組別指就內部管理目 的監控商譽的最低水平且不超過經營 分類。

#### Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business (see the accounting policy above) less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units (or groups of cashgenerating units) that are expected to benefit from the synergies of the combination, which represent the lowest level at which the goodwill is monitored for internal management purposes and not larger than an operating segment.

A cash-generating unit (or group of cash-generating units) to which goodwill has been allocated is tested for impairment annually, or more frequently whenever there is indication that the unit may be impaired. For goodwill arising on an acquisition in a reporting period, the cash-generating unit (or group of cashgenerating units) to which goodwill has been allocated is tested for impairment before the end of that reporting period. If the recoverable amount of the cash-generating unit is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill, and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit (or group of cash-generating units).

On disposal of the relevant cash-generating unit, the attributable amount of goodwill is included in the determination of the amount of profit or loss on disposal (or any of the cash-generating unit within group of cash-generating units in which the Group monitors goodwill)

The Group's policy for goodwill arising on the acquisition of an associate and a joint venture is described below.

聯營公司指本集團可對其產生重大影響的實體。重大影響指參與被投資公司的財務及營運決策的權力,而非控制或共同控制有關政策的權力。

合營公司乃一項合營安排,對安排擁 有共同控制權的訂約方據此對合營安 排的資產淨值擁有權利。共同控制權 指按照合同協定對一項安排所共有的 控制權,僅在相關活動必須獲得共同 享有控制權的各方一致同意方能決定 時存在。

## Investments in associates and joint ventures

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

The results and assets and liabilities of associates or joint ventures are incorporated in these consolidated financial statements using the equity method of accounting. The financial statements of associates and joint ventures used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate or a joint venture is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate or joint venture. Changes in net assets of the associate/joint venture other than profit or loss and other comprehensive income are not accounted for unless such changes resulted in changes in ownership interest held by the Group. When the Group's share of losses of an associate or a joint venture exceeds the Group's interest in that associate or joint venture, the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate or joint venture.

An investment in an associate or a joint venture is accounted for using the equity method from the date on which the investee becomes an associate or a joint venture. On acquisition of the investment in an associate or a joint venture, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The requirements of HKFRS 9 *Financial instruments* ("HKFRS 9") are applied to determine whether it is necessary to recognise any impairment loss with respect to the Group's investment in an associate or a joint venture. When necessary, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

When the Group ceases to have significant influence over an associate or joint control over a joint venture, it is accounted for as a disposal of the entire interest in the investee with a resulting gain or loss being recognised in profit or loss. When the Group retains an interest in the former associate or joint venture and the retained interest is a financial asset within the scope of HKFRS 9, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition. The difference between the carrying amount of the associate or joint venture and the fair value of any retained interest and any proceeds from disposing the relevant interest in the associate or joint venture is included in the determination of the gain or loss on disposal of the associate or joint venture. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate or joint venture on the same basis as would be required if that associate or joint venture had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate or joint venture would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) upon disposal/partial disposal of the relevant associate or joint venture.

The Group continues to use the equity method when an investment in an associate becomes an investment in a joint venture or an investment in a joint venture becomes an investment in an associate. There is no remeasurement to fair value upon such changes in ownership interests.

When a group entity transacts with an associate or a joint venture of the Group, profits and losses resulting from the transactions with the associate or joint venture are recognised in the Group's consolidated financial statements only to the extent of interests in the associate or joint venture that are not related to the Group.

#### **Revenue recognition**

#### Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15 Revenue from contracts with customers ("HKFRS 15").

Revenue from the sale of goods is recognised at the point in time when control of the asset is transferred to the customer, generally when the gas fuel is used by the customers and on delivery of the gas appliances and related products, respectively.

(b) Gas connection/design and construction services

Revenue from the provision of gas connection and design and construction services is recognised over time, measured based on the input method by reference to the costs incurred during the year relative to the estimated total costs for satisfaction of the contract. When the outcome of a construction contract for gas connection cannot be estimated reliably, revenue is recognised only to the extent of contract cost incurred that is probable to be recoverable.

Claims to customers are amounts that the Group seeks to collect from the customers as reimbursement of costs and margins for scope of works not included in the original construction contract. Claims are accounted for as variable consideration and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved. The Group uses the expected value method to estimate the amount of variable consideration to which the Group will be entitled.

### (c) Integrated energy service

Revenue from integrated energy service is recognised when control over a product or service is transferred to the customer at the amount of promised consideration to which the group is expected to be entitled.

## 其他來源的收益

利息收入採用實際利率法按應計基準 確認,方法為採用該利率將於金融工 具之預計年期(或較短期間,倘適用) 內之估計未來應收現金準確地貼現為 該金融資產之賬面淨值。

股息收入於股東收取付款之權利被確 立時確認,與股息相關的經濟利益可 能將流入本集團,且該股息金額能被 可靠地計量。

#### 合同資產

#### Revenue from other sources

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

The Group's accounting policy for recognition of revenue from operating leases is described in the accounting policy for leasing below.

#### **Contract assets**

A contract asset is the right to consideration in exchange for goods or services transferred to the customer. If the Group performs by transferring goods or services to a customer before the customer pays consideration or before payment is due, a contract asset is recognised for the earned consideration that is conditional. Contract assets are subject to impairment assessment, details of which are included in the accounting policies for impairment of financial assets. The contract assets are disclosed under a separate financial statement line item named "Assets related to contract works".

#### 合同成本

除資本化為存貨及無形資產的成本 外,倘符合以下所有條件,為履行與 客戶之間的合同產生之成本資本化為 資產:

- (a) 有關成本與實體可特定地識別之合同或預期訂立之合同有直接關係。

## Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

#### Contract costs

Other than the costs which are capitalised as inventories, and intangible assets, costs incurred to fulfil a contract with a customer are capitalised as an asset if all of the following criteria are met:

- (a) The costs relate directly to a contract or to an anticipated contract that the entity can specifically identify.
- (b) The costs generate or enhance resources of the entity that will be used in satisfying (or in continuing to satisfy) performance obligations in the future.
- (c) The costs are expected to be recovered.

The capitalised contract costs are amortised and charged to the consolidated statement of profit or loss and other comprehensive income on a systematic basis that is consistent with the transfer to the customer of the goods or services to which the asset relates. Other contract costs are expensed as incurred.

## Property, plant and equipment

Property, plant and equipment including buildings held for use in the production or supply of goods or services, or for administrative purposes (other than construction in progress) are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and accumulated impairment losses, if any.

Construction in progress includes property, plant and equipment in the course of construction for production or for own use purposes. Construction in progress is carried at cost less any recognised impairment loss. Construction in progress is classified to the appropriate category of property, plant and equipment when completed and ready for intended use. Depreciation of these assets, on the same basis as other property assets commence when the assets are ready for their intended use.

Depreciation is recognised so as to write off the cost of items of property, plant and equipment other than construction in progress over their estimated useful lives and after taking into account their estimated residual values, using the straightline method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

# Leasehold land and buildings under development for future owner-occupied purpose

When the leasehold land and buildings are in the course of development for production or for administrative purposes, the leasehold land component is classified as a right-of-use asset and amortised on a straight-line basis over the lease term. During the construction period, the amortisation charge provided for the leasehold land is included as part of costs of buildings under construction. Buildings under construction are carried at cost, less any identified impairment losses and are classified as property, plant and equipment. Depreciation of buildings commences when they are available for use (i.e. when they are in the location and condition necessary for them to be capable of operating in the manner intended by management).

#### **Investment properties**

Investment properties are properties held to earn rentals and/or for capital appreciation.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are stated at cost less subsequent accumulated depreciation and any accumulated impairment losses. Depreciation is recognised so as to write off the cost of investment properties over their estimated useful lives and after taking into account their estimated residual values, using the straight-line method.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposals. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the profit or loss in the period in which the item is derecognised.

## 獨立收購的無形資產

獨立收購及可使用年期有限的無形資 產按成本減累計攤銷及任何累計減值 虧損列賬。可使用年期有限的無形資 產按估計可使用年期以直線法計提攤 銷。

## 業務合併中收購的無形資產

業務合併中收購的無形資產會與商譽 分開確認,並初步按其於收購日期的 公平值確認(被視作其成本)。

Intangible assets include the Other intangible assets for city pipeline network.

#### Intangible assets acquired separately

Intangible assets acquired separately and with finite useful lives are carried at costs less accumulated amortisation and any accumulated impairment losses. Amortisation for intangible assets with finite useful lives is provided on a straight-line basis over their estimated useful lives.

#### Intangible assets acquired in a business combination

Intangible assets acquired in a business combination are recognised separately from goodwill and are initially recognised at their fair value at the acquisition date (which is regarded as their cost).

Subsequent to initial recognition, intangible assets acquired in a business combination with finite useful lives are reported at costs less accumulated amortisation and any accumulated impairment losses, on the same basis as intangible assets that are acquired separately.

An intangible asset is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising from derecognition of an intangible asset is measured as the difference between the net disposal proceeds and the carrying amount of the asset and is recognised in profit or loss in the period when the asset is derecognised.

#### Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

#### Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases for low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

#### (a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

(c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases of machinery and equipment (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office equipment that are considered to be of low value.

Lease payments on short-term leases and leases of lowvalue assets are recognised as an expense on a straightline basis over the lease term.

#### Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in revenue in profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

#### **Treasury shares**

Own equity instruments which are reacquired and held by the Company are recognised directly in equity at cost. No gain or loss is recognised in profit or loss on the purchase, sale, issue or cancellation of the Group's own equity instruments.

## Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is calculated using the weighted average method. Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

## Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short-term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

#### Investments and other financial assets

#### Initial recognition and measurement

Financial assets and financial liabilities are recognised on the consolidated statement of financial position when a group entity becomes a party to the contractual provisions of the instrument.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" above.

Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

For debt investments at fair value through other comprehensive income, interest income, foreign exchange revaluation and impairment losses or reversals are recognised in the statement of profit or loss and other comprehensive income and computed in the same manner as for financial assets measured at amortised cost. The remaining fair value changes are recognised in other comprehensive income. Upon derecognition, the cumulative fair value change recognised in other comprehensive income is recycled to the statement of profit or loss and other comprehensive income.

# Financial assets designated at fair value through other comprehensive income

Upon initial recognition, the Group can elect to classify irrevocably its equity instruments as equity instruments designated at fair value through other comprehensive income when they meet the definition of equity under HKAS 32 *Financial Instruments: Presentation* and are not held for trading. The classification is determined on an instrument-by-instrument basis.

Embedded derivatives are measured at fair value with changes in fair value recognised in the statement of profit or loss and other comprehensive income.

Reassessment only occurs if there is either a change in the terms of the contract that significantly modifies the cash flows that would otherwise be required or a reclassification of a financial asset out of the fair value through profit or loss category.

- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

## Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

#### General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information. The Group considers that there has been a significant increase in credit risk when contractual payments are more than 30 days past due.

For debt investments at fair value through other comprehensive income, the Group applies the low credit risk simplification. At each reporting date, the Group evaluates whether the debt investments are considered to have low credit risk using all reasonable and supportable information that is available without undue cost or effort. In making that evaluation, the Group reassesses the external credit ratings of the debt investments. Debt investments graded in the top investment categories by the Credit Rating Agency are considered to be low credit risk investments. It is the Group's policy to measure ECLs on such instruments on a 12-month basis. However, when there has been a significant increase in credit risk of debt investments since origination, the allowance will be based on the lifetime ECL. The Group uses the ratings from the Credit Rating Agency both to determine whether the debt instruments have significantly increased in credit risk and to estimate ECLs.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

- Stage 1 Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Stage 2 Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

#### Simplified approach

For trade receivables and assets related to contract works that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

The Group assesses at the end of each reporting period whether there is objective evidence that a financial asset or a group of financial assets is impaired. An impairment exists if one or more events that occurred after the initial recognition of the asset have an impact on the estimated future cash flows of the financial asset or the group of financial assets that can be reliably estimated. Evidence of impairment may include indications that a debtor or a group of debtors is experiencing significant financial difficulty, default or delinquency in interest or principal payments, the probability that they will enter bankruptcy or other financial reorganisation and observable data indicating that there is a measurable decrease in the estimated future cash flows, such as changes in arrears or economic conditions that correlate with defaults.

The subsequent measurement of financial liabilities depends on their classification as follows:

#### Financial liabilities at amortised cost

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss and other comprehensive income when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss and other comprehensive income.

#### Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contracts at the higher of: (i) the ECL allowance determined in accordance with the policy as set out in "Impairment of financial assets"; and (ii) the amount initially recognised less, when appropriate, the cumulative amount of income recognised.

## **Derecognition of financial liabilities**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the consolidated statement of profit or loss and other comprehensive income.

#### Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

#### **Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the costs of those assets until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

#### **Retirement benefit costs**

Payments to defined contribution retirement benefit plans/statemanaged retirement benefit schemes/the Mandatory Provident Fund Scheme are recognised as an expense when employees have rendered service entitling them to the contributions.

#### Short-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the services. All short-term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset.

A liability is recognised for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

## Other employee benefits

#### Defined benefit plan

The Group operates several defined benefit plans which require payments to be made to each qualifying employee in the PRC. The benefits are unfunded. The cost of providing benefits under the defined benefit plans is determined using the projected unit credit actuarial valuation method.

Remeasurements arising from defined benefit pension plans, comprising actuarial gains and losses, the effect of the asset ceiling (excluding amounts included in net interest on the net defined benefit liability) and the return on plan assets (excluding amounts included in net interest on the net defined benefit liability), are recognised immediately in the consolidated statement of financial position with a corresponding debit or credit to retained profits through other comprehensive income in the period in which they occur. Remeasurements are not reclassified to profit or loss in subsequent periods.

Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profit will be available against which those deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, associates and joint ventures, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of the reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Where current tax or deferred tax arises from the initial accounting for a business combination, the tax effect is included in the accounting for the business combination.

#### **Dividends**

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

#### **Foreign currencies**

Items included in the financial statements of each of the group entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional currency and the Group's presentation currency.

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Nonmonetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the group entities are translated into the presentation currency of the Group (i.e., HK\$) using exchange rates prevailing at the end of reporting period. Income and expenses items are translated at the average exchange rates for the year. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve.

The functional currency of a group entity is changed only where there is a change to the underlying transactions, events and conditions relevant to the group entity. The group entity applies the translation procedures applicable to the new functional currency prospectively from the date of the change. At the date of the change, the group entity translates all items into the new functional currency using the prevailing exchange rate at that date and the resulting translated amounts for non-monetary items are treated as their historical cost.

Goodwill and fair value adjustments on identifiable assets acquired arising on an acquisition of a foreign operation on or after 1st January, 2005 are treated as assets and liabilities of that foreign operation and translated at the rate of exchange prevailing at the end of the reporting period. Exchange differences arising are recognised in the translation reserve.

# Impairment losses on tangible and intangible assets other than goodwill

At the end of the reporting period, the Group reviews the carrying amounts of its tangible and intangible assets with finite useful lives to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss, if any.

When it is not possible to estimate the recoverable amount of an asset individually, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash – generating units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a cash-generating unit) for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit. An impairment loss is recognised immediately in profit or loss.

A reversal of an impairment loss is recognised immediately in profit or loss.

#### **Government grants**

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Government grants related to depreciable assets are recognised as deferred income in the consolidated statement of financial position and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets. Other government grants are recognised as revenue over the periods necessary to match them with the costs for which they are intended to compensate, on a systematic basis. Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

#### Long term award scheme

The cost of acquisition of the Company's shares pursuant to the long-term award scheme is recorded as shares held for incentive award scheme. The shares held for incentive award scheme will be disposed of for cash which will be distributed to the eligible employees.

The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

#### Critical judgements in applying accounting policies

The following are the critical judgements, apart from those involving estimations (see below), that the directors have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

The shareholders of the PRC Entities signed memorandums in which the other shareholders would agree the Group's decisions on operating, investing and financing activities of the PRC Entities, and the other shareholders would agree the appointment of the entire senior management of the PRC Entities nominated by the Group. After assessment, the directors concluded that the Group has sufficiently dominant voting interest to direct the relevant activities of the PRC Entities, and therefore, the Group has control over the PRC Entities.

#### **Estimation uncertainty**

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets within the next financial year.

#### Impairment of goodwill

Determining whether goodwill is impaired requires an estimation of the recoverable amount of the cash-generating units to which goodwill has been allocated, which is the higher of the value in use and fair value less costs of disposal. The value-in-use calculation requires the Group to estimate the future cash flows expected to arise from the cash-generating unit and a suitable discount rate in order to calculate the present value. Where the actual future cash flows are less than expected, or changes in facts and circumstances result in downward revision of future cash, a material impairment loss may arise. As at 31st December, 2023, the carrying amount of goodwill was HK\$4,911,756,000 (2022: HK\$2,154,360,000). Details of the recoverable amount calculation are disclosed in note 20.

#### Recognition of gas connection revenue

Revenue from gas connection revenue is measured based on the input method, which is to recognise revenue on the basis of the Group's efforts or inputs to the satisfaction of a performance obligation relative to the total expected inputs to the satisfaction of that performance obligation. Accordingly, any changes to the actual costs incurred and the estimated budgeted costs may have material impact on the revenue recognised in each accounting period over the contract term. The management of the Group is required to exercise significant judgments in the assessment of the progress of satisfaction of performance obligation, and the completion and accuracy of forecast costs to complete.

#### Estimation of useful lives of property, plant and equipment

Management estimates the useful lives of property, plant and equipment based on the expected lifespan of those property, plant and equipment. The useful lives of property, plant and equipment could change significantly as a result of technical innovation. When the actual useful lives of property, plant and equipment are different from their estimated useful lives due to the change of commercial and technological environment, such difference will impact the depreciation charges and the amounts of assets written down for future periods.

The carrying amount of property, plant and equipment at 31st December, 2023 was HK\$61,198,859,000 (2022: HK\$48,464,774,000).

- (iii) Comprehensive services sales of gas appliances, related products and extended services;
- (iv) Design and construction services design, construction, consultancy and management for gas connection projects;
- (v) Gas stations sale of gas fuel in natural gas filling stations.

No operating segments have been aggregated in arriving at the reportable segments of the Group.

Segment results represent the profit before taxation earned by each segment, excluding sundry income, interest income, rental income, finance costs, depreciation of investment properties, central administrative costs and directors' salaries. This is the measure reported to the executive directors of the Company for the purpose of revenue allocation and assessment of segment performance.

Under the Law of the People's Republic of China on Enterprise Income Tax (the "EIT Law") and Implementation Regulation of the EIT Law, the tax rate of the PRC subsidiaries is 25% except for certain group entities which are entitled to various concessionary tax rates or tax exemptions and reliefs.

According to a joint circular of the Ministry of Finance and the State Administration of Taxation, Cai Shui 2011 No. 1, only the profits earned by foreign-investment enterprises prior to 1st January, 2008, when distributed to foreign investors, can be grandfathered and exempted from withholding tax. Whereas dividend distributed out of the profits generated thereafter, shall be subject to the Enterprise Income Tax at 5% or 10% and withheld by the PRC entities, pursuant to Articles 3 and 27 of the New Law and Article 91 of its Detailed Implementation Rules.

Lump sum payments were generally made upfront to acquire the leased land from the owners with lease periods of 2 to 50 years, and no ongoing payments will be made under the terms of these land leases. Leases of buildings generally have lease terms between 2 and 25 years, and leases of plant, machinery and equipment have lease terms between 2 and 24 years.

The recoverable amounts of the CGUs are determined based on value-in-use calculations. The key assumptions for the valuein-use calculations are those regarding the discount rates, future revenue and operating costs. Management estimates discount rates using pre-tax rates that reflect current market assessments of the time value of money and the risks specific to the CGUs. The future revenue and operating costs are based on industry growth forecasts and management's past practices and expectations of future changes in the market.

The Group prepares cash flow forecasts derived from the most recent financial budgets approved by senior management for the next 5 years, which is the general development period for the sale of liquefied gas and the gas connection business and extrapolates cash flows for the period beyond the budget period based on the estimated growth rates of 5% for the first 5 years and 2% for the remaining years (2022: 5% for the first 5 years and 2% for the remaining years). The rate used to discount the forecast cash flows for the CGUs is 6.2% (2022: 6.2%). In the opinion of the directors, no material impairment loss on goodwill on gas operation was identified at the end of the reporting period. Management believes that any reasonably possible change in any of these assumptions would not cause the aggregate carrying amount of the CGU.

As at 31st December, 2022, the determination of goodwill arising from the acquisition of 蘇創燃氣股份有限公司 and 台州 燃氣有限公司 was based on a provisional basis. The fair value assessment of the identifiable assets and liabilities of 蘇創燃氣 股份有限公司 and 台州燃氣有限公司 has been finalised in 2023 and the goodwill arising from these acquisitions is determined at HK\$204,557,000 and HK\$64,159,000 as at 31st December, 2023, respectively.

#### **32. MEDIUM-TERM NOTES**

On 3rd November, 2022, 重慶燃氣 issued medium-term notes with principal amount of RMB500,000,000 (equivalent to HK\$551,740,000) at an offer price of 100% of the face values of the medium-term notes. The medium-term notes bear coupon interest at 2.90% per annum, payable at maturity and annually in arrears and would be due on 3rd November, 2025. These borrowings were unsecured and carried effective interest rate of 2.90% per annum.

#### **33. OTHER LONG-TERM LIABILITIES**

The other long-term liabilities mainly consist of payables for acquisition of operating rights for the city pipeline network, defined benefit obligations and other payables.

In 2023, the Group operates several unfunded defined benefit plans which require payments ranging from HK\$275 to HK\$59,307 (2022:HK\$259 to HK\$59,307) per year to be made to each qualifying employee in the PRC. The plan is exposed to interest rate risk and the risk of changes in the life expectancy for pensioners. The defined benefit obligations with a present value of HK\$311,581,000 were carried out on 31st December, 2023 (2022: HK\$323,463,000) by Willis Towers Watson using the projected unit credit actuarial valuation method.

#### **36. LONG TERM AWARD SCHEME**

On 1st December, 2008, the Company adopted the share repurchased cash award scheme ("Incentive Award Scheme") as an incentive to retain and encourage the employees for the continual operation and development of the Group.

Pursuant to the Incentive Award Scheme, existing shares of the Company will be purchased by the trustee from the market out of cash contributed by the Group and be held in trust for the selected employees until such shares are vested with the selected employees. No restricted shares will be granted if the aggregate number of restricted shares awarded throughout the duration of the scheme is to be in excess of 5% of the issued share capital of the Company at the adoption date of the scheme. The maximum number of restricted shares which may be awarded to a selected employee under the Incentive Award Scheme shall not exceed 0.5% of the issued share capital of the Company from time to time.

On 16th March, 2010, the Company amended the Incentive Award Scheme such that cash instead of restricted shares will be awarded. The Company will utilise the proceeds generated from disposal of the restricted shares held by the trustee for making cash awards under the Incentive Award Scheme.

No disposal of shares by the trustee to the market was noted during the years ended 31st December, 2022 and 2023.

The Group participates in both a retirement benefit scheme which is registered under the Occupational Retirement Scheme Ordinance (the "ORSO Scheme") and a Mandatory Provident Fund Scheme (the "MPF Scheme") established under the Hong Kong Mandatory Provident Fund Schemes Ordinance. The assets of the schemes are held separately from those of the Group, in funds under the control of trustees. Employees who were members of the ORSO Scheme prior to the establishment of the MPF Scheme were offered a choice of staying within the ORSO Scheme or switching to the MPF Scheme, whereas all new employees joining the Group on or after 1st December, 2000 are required to join the MPF Scheme.

The ORSO Scheme is funded by monthly contributions from both employees and the Group based on a specified percentage of the employee's basic salary, depending on the length of service with the Group. Where there are employees who leave the ORSO Scheme prior to vesting, the contributions payable by the Group are reduced by the amount of forfeited contributions. No forfeited contributions were utilised in this manner for both years.

For members of the MPF Scheme, the Group contributes 5% of relevant payroll costs or at a monthly maximum cap of HK\$1,500 for each person to the scheme, where contribution is matched by the employees.

At 31st December, 2023 and 2022, the amount of forfeited contributions available to reduce contributions payable in the future years was insignificant.

#### PRC

The employees of the Group in the PRC are members of statemanaged retirement benefit schemes operated by the local government in the PRC. The Group is required to contribute a specified percentage of the payroll costs to the retirement benefit schemes to fund the benefits. The only obligation of the Group with respect to the retirement benefit schemes is to make the specified contributions.

The Group operates several unfunded defined benefit plans which require payments ranging from HK\$275 to HK\$59,307 (2022: HK\$259 to HK\$59,307) per year to be made to each qualifying employee in the PRC.

### 42. CAPITAL RISK MANAGEMENT

The Group manages its capital to maintain a balance between continuity of cash flows from operating activities and the flexibility through the use of bank and other borrowings. The Group also monitors the current and expected liquidity requirements and its compliance with lending covenants regularly to ensure that sufficient working capital and adequate committed lines of funding are maintained to meet its liquidity requirements. The Group's overall strategy remains unchanged from prior years.

The capital structure of the Group consists of debts, which include bank and other borrowings, senior notes, net of bank balances and equity attributable to owners of the Company, comprising issued capital, retained profits and other reserves.

The management of the Group reviews the capital structure on a regular basis. As part of this review, management considers the cost of capital and the associated risks, and takes appropriate actions to adjust the Group's capital structure through the payment of dividends, new share issues as well as the issue of new debts or the redemption of existing debts.

Details of these financial instruments are disclosed in the respective notes. The risks associated with these financial instruments and the policies on how to mitigate these risks are set out below. The Group manages and monitors these exposures to ensure that appropriate measures are implemented in a timely and effective manner.

#### Interest rate risk

The Group is exposed to cash flow interest rate risk in relation to prevailing market interest rates on bank balances and pledged bank deposits and restricted cash (see notes 27 and 26 for details of these balances) and floating-rate amounts due from/to joint ventures, amounts due to intermediate holding companies and bank and other borrowings (see notes 28 and 31 for details of these borrowings). Management continuously monitors interest rate fluctuation and will consider further hedging interest rate risk should the need arise.

The Group is also exposed to fair value interest rate risk in relation to fixed-rate bank and other borrowings, amounts due from intermediate holding companies, amounts due from fellow subsidiaries and senior notes (see notes 24 and 32 for details). Management continuously monitors interest rate exposure.

#### Interest rate sensitivity analysis

The sensitivity analysis has been determined based on the exposure to interest rates for interest-bearing bank balances, other deposits, pledged bank deposits, amounts due from/to joint ventures, amounts due to intermediate holding companies and bank and other borrowings. The analysis is prepared assuming that those balances outstanding at the end of each reporting period were outstanding for the whole year. A 10 or 50 basis points increase or decrease which represents management's assessment of the reasonably possible change in interest rates is used.

#### Interest rate sensitivity analysis (Continued)

If the interest rate on bank balances, other deposits, pledged bank deposits and restricted cash, loans to a joint venture and amounts due from/to joint ventures carried at variable rates had been 10 basis points higher/lower and all other variables were held constant, the pre-tax profit for the year ended 31st December, 2023 would increase/ decrease by HK\$12,033,000 (2022: HK\$8,282,000). If the interest rate on floating-rate bank and other borrowings and amounts due to intermediate holding companies had been 50 basis points higher/lower and all other variables were held constant, the pre-tax profit for the year ended 31st December, 2023 would decrease/increase by HK\$33,644,000 (2022: HK\$34,664,000). This is mainly attributable to the Group's exposure to interest rates benchmarked to HIBOR on its floating-rate bank and other borrowings and amounts due to intermediate holding companies.

The Group's exposure to cash flow interest rate risk is mainly concentrated on the fluctuation of the HIBOR and the People's Bank of China Base Rate.

#### Credit risk

The Group's maximum exposure to credit risk in the event of the counterparties' failure to perform their obligations in relation to each class of recognised financial assets is the carrying amount of those assets as stated in the consolidated statement of financial position. In order to minimise the credit risk, the Group has policies in place for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts.

Before accepting any new customer, the Group carries out searches on the creditability of the new customer and assesses the potential customer's credit quality and defines credit limits by customer. Limits attributed to customers are reviewed once a year.

In addition, the Group reviews the recoverability of each individual trade debt on a regular basis to ensure that adequate impairment losses are made for irrecoverable amounts. In this regard, the Group considers that the credit risk is significantly reduced.

The credit risk on bank deposits is limited because the counterparties are financial institutions with high credit standing.

In the management of liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. Management also monitors the utilisation of bank borrowings and ensures compliance with loan covenants, if any.

At 31st December, 2023, the Group had net current liabilities of HK\$15,655,135,000. Taking into account of the unutilised banking facilities of HK\$21,845,964,000 and internally generated funds of the Group and the other factors described in note 2, the Group has sufficient working capital for its present requirements for the next twelve months from 31st December, 2023.
